Q: Our county has high population of medically fragile students. Is it suggested we do medical exemptions for them? Our severe population exceeds the 1% and that doesn't include others that are on extended standards.

A: No, medical exceptions are not specific to a population of students and should never be applied to all students within any one category of disability. It is recommended that medical exceptions be requested on an individual basis for students who are unable to participate in testing due to a medically related condition that impacts their ability to participate in testing. The expectation is that all students are receiving instruction and that most will participate in the required grade level testing with appropriate accommodations.

Q: Can these codes be used for EC students who transfer from another state and would normally be placed in an OCS pathway but did not have that option in their previous district?

A: If the courses have the same or similar standards, course credit may be applied. For example, World History and American History (required for OCS) do not have the same standards, so Social Studies credit may not be applied when the student has already taken World History; however, the student may be given elective credit for World History. Remember, the completion of the OCS results in the student receiving a NC High School Diploma, so we must maintain fidelity in instruction and the application of course credit. Q: Does the scheduling apply to Charter schools as well?

A: Yes, all students should receive instruction in the required content areas and should be scheduled accordingly using the state course codes.

Q: Does HB 317 need to be completed if we don't have any students it applies to?

A: Each LEA that had students identified as primary DF or HI per the April 1, 2018 headcount, received an email with links to the electronic reporting tool. Q: Not all new forms are posted to the DPI website. Is it possible to get them all posted as we need to start using them during the blackout period (we use EdPlan)?

A: As a reminder, the new forms that are currently posted on the website were provided in response to many requests to view the changes to formatting. Also, given the development logic inside of ECATS, the forms populate with the information and decisions made by the user/IEP team, therefore the posted forms may not account for all possible decisions a team might make (ex. benchmarks/objectives, transition, etc.). During the blackout period, LEAs may continue to use locally developed forms or “old” current forms from the EC Division website. LEAs may also use the new forms with the understanding of the limitations noted in the previous sentence. Revised or additional new forms will not be added prior to blackout.
