- Goal 1: By June 2016, the percentage of students scoring proficient on the Reading (End of Grade) Assessment will increase from 32.1% to 54.2% with an increase for African American students from 30% to 53.3%.
- Goal 2: By June 2016, the percentage of students scoring proficient on the Math (End of Grade) Assessment will increase from 30.5% to 44.5% with an increase for African American students from 25% to 43.2%.
- Goal 3: By June 2016, the percentage of students scoring proficient on the Science (End of Grade) Assessment will increase from 41.7% to 48.6% with an increase for African American students from 31.4% to 40%.

### **Regional Support:**

The regional office will provide

- Frequent team walk-thru visits and feedback to principal about the quality of observed instruction and the alignment to curriculum standards and pacing expectations.
- On site coaching of principal, curriculum facilitator, and identified teachers (as requested and pending resource availability).
- Provide four professional development Fundation sessions for 2<sup>nd</sup> and 3<sup>rd</sup> grade classroom teachers.

#### **Central Office Support:**

Central Office based Curriculum and Instruction staff has prioritized standards and revised pacing guides in tested subjects and grades based on NCDPI test specifications. This creates more targeted and purposeful instruction aligned with state summative assessments. Low performing schools will complete diagnostic assessments linked to pacing in tested subject areas. As a result, schools will be able to provide targeted standard-level remediation to students. Additionally, several members of our central office based

curriculum team have been placed in our four regions so that low performing schools receive additional support in the areas of literacy, math and science. Two district wide Learning Conferences are scheduled in the fall and spring for teachers that will focus specifically on instructional strategies to maximize student outcomes. Teachers will be able to take strategies directly back to their classrooms for immediate implementation.

# SUMMARY OF SCHOOL DATA ANALYSIS AND/OR COMPREHENSIVE NEEDS ASSESSMENT

# 1. What does an analysis of your school data and/or a comprehensive needs assessment tell you about the school's strengths? Our EOY school data indicates our Kindergarten students achieved well below average as measured by TRC and below average as measured by DIBELs. Our first grade students achieved below typical progress as measured by TRC and below average as measured by DIBELs. Our second grade students demonstrated above average progress as measured by TRC and well below typical progress as measured by DIBELs. Our third grade students are demonstrated well below typical progress as measured by TRC and well below typical progress as measured by DIBELs. Our third grade EOG reading data indicates a 7% decline in performance over the previous year, our 4th grade EOG reading data indicates a 7% increase in overall performance, and our 5th grade EOG data indicates a slight increase of .3. Our third grade EOG math data indicates a 4.4% decline from the previous year of performance. Our fourth grade math EOG data indicates an 18.2% increase over the previous year, and our 5th grade EOG math data indicates a 12.4% increase over the previous year. Our 5th grade EOG science EOG data indicates 27.7% increase in student performance over the previous year. Our 4th grade black students demonstrated an increase in performance in reading from the previous year as measured by EOG testing. Our 3rd and 5th grade black students demonstrated slight decline reading performance. Our 5th grade Hispanic students demonstrated an 18.2% increase in reading performance over the previous year. In math our 4th grade math students demonstrated a 21% increase in performance and our 5th grade black students demonstrated an increase of 15.9% as measure by the math EOG. Our third grade black students declined in performance in math and reading from the previous year. Our black and Hispanic students both demonstrated growth on the 5th grade science EOG, 27.8% and 18.2%, respectively 2. What does the data analysis and/or comprehensive needs assessment tell you about the school's gaps or opportunities for improvement? Opportunities for improvement include increasing proficiency rates in all subject areas in all sub-groups. A focused area of improvement is with our black students and EC students. DIBELS end of year data reporting indicates all students are performing below average. A continued focus on soliciting community support of teachers which contributes to the overall success of students is an area to develop. Sufficient access to instructional technology is an area noted on the school improvement plan as a need and is a need to increase student engagement and achievement.
