  - a. Our PSU and proposed school(s) will engage in planning with the program provider in spring 2026.
  - b. Our PSU and proposed school(s) will support the program provider to deliver Annual Books Fairs with fidelity to the program model in spring 2027, spring 2028, and spring 2029.
  - c. Our PSU and proposed school(s) understand that, to enable a rigorous evaluation, an independent study team will use a randomized lottery to select



half of the schools for participation, while the other half continues with standard programming.<sup>1</sup>

- d. Our PSU and proposed school(s) will work with the independent study team to help facilitate data collection (likely minimal) for the randomized-controlled trial study, as needed.
  - e. Our PSU and proposed school(s) will provide funding for its 50 percent share of the program costs, as calculated using the Costing Tool (see “Maximum Cost to PSU over 3 Years” in the “Cost Estimate” sheet).
