Session Law 2016-79 (HB242) Section 1.6 modifies [G.S. 115C-218.105\(d\)](#), requiring the local education agencies (LEA) to provide to the State Board of Education detail information related to the calculation and transfer of the per pupil share of the LEA's local current expense fund. LEAs are required to provide this information to the State Board of Education by November 1 of each year.
