## Report to the North Carolina General Assembly on Advanced Courses in Mathematics, per G.S. 115C-81.36.(c)

G.S. 115C-81.36 directs that, when practicable, local boards of education shall offer advanced learning opportunities in mathematics in grades three through five, and advanced courses in mathematics in all grades six and higher. For those advanced courses offered in mathematics in grades six and higher, any student scoring at the highest level on the end-of-grade or end-of-course test for the mathematics course in which the student was most recently enrolled shall be enrolled in the advanced course for the next mathematics course in which the student is enrolled. The legislation also specifically outlines that a student in seventh grade scoring at the highest level on the seventh-grade mathematics end-of-grade test shall be enrolled in a high school level mathematics course in eighth grade.

In accordance with this legislation, the NC Department of Public Instruction (NCDPI) shall submit a report to the Joint Legislative Education Oversight Committee containing data collected for the current school year on the number and demographic information of students who were *eligible* for advanced mathematics courses under this section, including high school level mathematics courses in eighth grade. In addition, the report will include the number and demographic information for all *eligible* students who *were placed* in advanced mathematics courses and those who *were not placed* in advanced mathematics courses. Finally, the report shall include information on the type and format of advanced mathematics courses provided and shall also include any feedback provided by local boards of education on the implementation of G.S. 115C-81.36.

To comply with this legislation, NCDPI extracted enrollment data for all students currently enrolled in grades six and higher who were *eligible* for advanced courses from the NC Student Information System (NC-SIS) for all Local Education Agencies (LEAs). During this academic year, data was delayed due to the state's two phased transition to the new NC-SIS.

To support this data collection, all LEAs were required to run the Advanced Mathematics Course (AMC) report within either the PowerSchool or Infinite Campus student information system platforms, depending on which is in use in the LEA. During the reporting period, LEAs had the opportunity to review and verify the data contained in the report, and if applicable, use the reporting override feature within PowerSchool or the Data Correction worksheets available to Infinite Campus users to manage any data corrections for students deemed to be either missing from the report, or erroneously reported as not placed in an advanced mathematics course before submitting the report. The data tables below respond to the legislated requirements, documenting the *eligible* students who were either *placed or not placed* in advanced mathematics courses, and disaggregating the information by sex, grade level, and ethnicity/race. These tables include a comprehensive overview of grades 6-12, and a specific look at grade 8 data, as the legislation specifically requires reporting for grade 8 students eligible for enrollment in high school content. Additionally, NCDPI has provided a detailed view of the demographic information, including sex, race/ethnic group, migrant status, homeless status, English Learner status, Academically or Intellectually Gifted (AIG) status, and Exceptional Children (EC) status for all *eligible* students placed and not placed listed by each of the 115 traditional LEAs. Finally, an overview table of all LEAs is provided with the total number of eligible students and of those, the percentage of students placed in advanced mathematics courses.

Note that the data tables do not represent *comprehensive enrollment* in advanced mathematics courses, rather, the information reflects those students who scored at the highest level on an end-of-grade (EOG) or end-of-course (EOC) mathematics assessment in the previous school year and are therefore automatically eligible for advanced mathematics course enrollment in the current school year, as outlined in the legislation.

At the end of the report, NCDPI provides conclusion statements drawn from the data.

## Summary of Findings December 2024

G.S. 115C-81.36 became law on July 11, 2019, with an expectation for full implementation during the 2019-2020 school year. As noted above, the legislation outlined a reporting requirement to share the number and demographic information for all students scoring at the highest level on an EOGor EOC mathematics assessment, and the same information for those eligible students who were both placed and not placed in an advanced mathematics course in the subsequent school year.

In the data set for the 2024-25 school year, the following observations are noted:

- In the 2023-24 school year, there were 59,545 students in grades 6-12 scoring at the highest level on either an EOG or EOC mathematics assessment. This represents an increase of 1,359 students over the previous academic year. In alignment with the legislation, these students were then automatically eligible for placement in an advanced mathematics course in the current school year. Of those eligible students:
  - **93%** (55,480) are currently placed in an advanced mathematics course, and
  - **7%** (4,065) are not currently placed in an advanced mathematics course.
- NCDPI has noted increases in the number of students eligible every year since reporting began in 2021, and the number now represents 10-13% of all students testing on EOG and EOC mathematics assessments, depending on the grade level.
- In addition, there are **55,480** students currently placed in advanced mathematics courses based on the EOG or EOC mathematics assessments. This number represents the highest number of students auto-enrolled in advanced mathematics courses since the legislation was enacted and 900 more that the previous year.
- While there are more total students eligible for advanced mathematics courses, this data does show **an overall decrease in the percentage** of students placed in advanced mathematics courses moving from 94% to 93% placed. This decrease can be seen throughout the disaggregated data as we examine the data of various student groups and the grade level and sex data as well.
  - In reviewing the grade level data, decreases were seen in multiple grade levels, with the largest decreases shown in grades 6 and 12. These grades have historically reported the lowest percentage of students placed in advanced mathematics courses.
  - In examining the data by the students' racial/ethnic group, there were decreases in the percentage of eligible students placed in advanced mathematics courses among *all* student groups.
- The American Indian or Alaska Native population of students continues to be the most frequently missed, or not placed, in advanced mathematics courses.
  - In grades 6-12, 16% of American Indian or Alaska Native students are not placed in an advanced course, as compared to counterparts ranging from 4-10% not

placed. The data indicates that all student groups showed some decrease in percentage of the eligible students placed, but for other student groups, the decrease was 1-2%.

- For American Indian or Alaska Native students in 8<sup>th</sup> grade, the current placed rate is 93%, with 7% of students not placed in advanced mathematics courses. Again, while the data indicates some decreases in percentage of eligible students placed for *all* student groups, among other groups, the percentage of eligible students not placed in advanced math courses is generally between 2-4%.
- During the previous academic year, the Native Hawaiian or Other Pacific Islander population was noted as having 100% of eligible students placed in grade 8, and this year the percentage of placed students was 93%. However, the Native Hawaiian or Other Pacific Islander group in grades 6-12 has remained consistent with greater than 95% placed in advanced mathematics courses.
- A major focus of the legislation was the guaranteed opportunity for current 8<sup>th</sup> grade students who scored at the highest level in the previous school year (on the 7<sup>th</sup> grade end of grade mathematics assessment) to be enrolled in a high school mathematics course during 8<sup>th</sup> grade. The initial data indicates that the overall number and percentage of students placed in advanced mathematics is now 97%, a slight decrease (1%) from the 2023-2024 reporting year.
- When examining the data by sex, the data indicates that the percent of males and females overall placed in advanced mathematics courses were similar in grade 8 – with 98% of females placed and 97% of males placed and across grades 6-12, the male and female students are placed at 93 and 94% respectively.
- In each of the prior years of reporting, NCDPI has noted inconsistencies in the placement of students in advanced math course offerings throughout high school. While this year's placement rate for 9<sup>th</sup> 11<sup>th</sup> grade students ranges between 94 and 96%, the percent of eligible 12<sup>th</sup> grade students placed in advanced courses is currently 82%, which represents a 2% decrease from the previous report year.
- In grades 9-12, districts are offering various advanced mathematics courses to meet student needs, interests, and post-secondary plans:
  - Courses are offered in a traditional face to face setting, as well as provided in an online learning environment by the LEA or external partner.
  - Schools are offering a variety of mathematics courses, including Honors, University, Community College, Advanced Placement, International Baccalaureate, and Cambridge.

For the first time, NCDPI has begun to analyze and evaluate the overall placement data for each LEA to determine what, if any, actionable findings might be gleaned from the data. This new data review is included in *Table 7: Overview of LEA percentage of all eligible students currently placed in an advanced mathematics course*. Initial review of this data shows that:

- 21 districts are currently placing below 70% of eligible students
- 71 districts are placing greater than 90% eligible students
- 15 districts are placing 100% of those students who are eligible.

To better understand this baseline data, the NCDPI team will gather additional information from all districts via survey, regarding the challenges a district may face in implementing the legislation, as well as the factors contributing to a districts' successful implementation of the legislation. This data will be analyzed by an internal cross agency team at NCDPI and will be shared with district leaders and the Regional Directors from each of the state's education regions.

This collaboration will support efforts to consider trends across the region, facilitate the sharing of best practices, and determine what additional support may be necessary to continue to increase the number and percentage of eligible students placed in advanced mathematics courses. In addition, NCDPI will continue to provide professional learning opportunities to examine mindsets, policies and practices focused around advanced mathematics opportunities and acceleration as a strategy to meet student needs.

Finally, NCDPI will look into the higher likelihood of non-placement in advanced math courses for students of American Indian/ Alaska Native descent. As mentioned above, during each year of reporting, the American Indian/ Alaska Native students are the most frequently not placed student group. Therefore, NCDPI will provide additional guidance for districts to ensure districts:

- develop a process of internal accountability to ensure that the families of all students who score at the highest level are properly notified of advanced math course eligibility and are scheduled accordingly
- communicate with parents/guardians to ensure understanding their rights related to the advanced math course eligibility and
- address concerns parents/guardians may have when students are experiencing an advanced course for the first time.

## Feedback from LEAs throughout this year's reporting process and efforts to implement the legislation:

1. As has been shared before, many LEAs have expressed concern about the number of

12th grade students who may have scored at the highest level on the NC Math 3 end of course mathematics assessment and who are currently not enrolled in an advanced course. During this report window, only 82% of eligible 12th grade students are enrolled in an advanced mathematics course. LEA personnel believe this happens because either the students have met the graduation requirements in mathematics and have chosen not to enroll in mathematics courses, or the students anticipate enrolling in one of many local dual enrollment offerings – and those may not be scheduled at the time of the AMC reporting (early fall semester). So, LEAs would like the opportunity to somehow share documentation about each students' situation. To that end, our NCDPI team is working with the NC-SIS programmers to enhance the AMC report functionality to allow for this additional explanation.

- 2. This year as the state has moved to a new NC-SIS, development of the AMC report took longer than anticipated, and led to a delay in those districts having the opportunity to access the AMC report information. As the NCDPI team has examined the overall LEA placement data however, it appears that while having the report early in the school year may have been more convenient, receiving the report later in the year, did not impact the overall ability of a district to place students appropriatelyThe achievement data for students was available and LEAs in both NC-SIS platforms had lower placement of eligible students.
- 3. LEAs continue to express a desire to be able to report those cases in which a student is not placed in an advanced course due to a parent's written request, to help better understand the context for local data. NCDPI will continue to work with our state reporting system to update the AMC report to find a mechanism for sharing the number of and demographic information for those students who are eligible for placement in an advanced math course, but who have a parent/guardian's written request to not enter the advanced course.
