We anticipate an update to the worksheet in ECATS very soon. In the meantime, as we continue to work with PCG to update the SLD worksheet in ECATS, teams will need to continue to complete the information in ECATS utilizing the crosswalk <u>"Tip Sheet: Eligibility</u> <u>Worksheet - Specific Learning Disability Effective July 1, 2020"</u> to document the new requirements on the old form in ECATS. District and school leadership should develop a process for teachers to follow regarding inclusion of the paper version in conjunction with completion of documentation in ECATS.
