The AU Eligibility Worksheet has been updated to reflect the correct formatting and is now live in ECATS.

December Child Count

The December Child Count captures federal reporting data on students receiving special education as of December 1, 2021. The December Child Count opens December 1, 2021 and must be certified by close of business December 20, 2021. It is expected that EC Directors/Coordinators certify the December Child Count by the due date. The integrity of the data is always at risk when the DPI must finalize the data for the district. So, it is imperative that the EC Director/Coordinator reviews and certifies the December Child Count data on time. If someone other than the EC Director/EC Coordinator certifies the December Child Count, the Child Count Verification form must be completed and submitted to Khalilah O'Farrow-Boulware at Khalilah.ofarrow@dpi.nc.gov. The December 2021 Child Count Verification Form is accessible from the ECATS Main Menu > Resources section > Federal Reporting tab.
