Reminder: ECATS Beginning-of-Year (BOY)

ECATS has returned to its normal file schedule and is importing 2022-2023 school data. Please remember that a higher volume of transfers due to BOY is occurring, and record transfers in ECATS could take longer than usual.

The process to update graduation data in ECATS will occur after the August deadline for entry of graduation data into PowerSchool. Once this file is processed, students who have graduated will be exited in ECATS. After that point, districts will be able to select the Modified Exit Reason in ECATS for the 2021-2022 Exit Count and these students will no longer appear active in ECATS.

Indicator 7 - NOW OPEN!

All Public-School Units are responsible for certifying Indicator 7: Preschool Outcomes in ECATS. The certification schedule for Indicator 7 began August 1, 2022 and is due by close of business August 19, 2022.

Indicator 11

All Public-School Units are responsible for certifying Indicator 11: Child Find in ECATS. The certification schedule for Indicator 11 begins October 3, 2022 and is due by close of business October 31, 2022.

Indicator 12

Indicator 12 must be submitted via spreadsheet by all Traditional Public-School Units prior to the due date of October 31, 2022. Charter Schools and State Operated Programs do not need to submit an Indicator 12



spreadsheet this year. Indicator 14

Selected Public-School Units are responsible for documenting post school outcomes survey data in ECATS for each student that graduated, dropped out, received a certificate, or aged out during the 2020-21 school year as reported in the 2020-21 Exit Report. All Post-School Outcome survey data are to be entered in ECATS by September 16, 2022. Your cooperation in meeting the deadline for data submission is greatly appreciated. MTSS Module

MTSS Intervention Plan Translation

The MTSS Intervention Plan document will be available for document translation in ECATS beginning late on Friday, August 12, 2022. Currently, ECATS offers document translation for the following languages: Spanish, Chinese, French, German, Italian, Japanese, Korean, Portuguese, or Russian.

To translate a student's documents, the Document Language data field must be updated on the student's Personal Information page. Only authorized LEA users may edit this field. For guidance on updating this field, refer to the **ECATS Translation Quick Reference Guide** under Resources on the ECATS Main Menu page. To translate the MTSS Intervention Plan document, go to the student's plan page and click Create Document. On the document creation window, fill in the relevant information, then select the checkbox for "Include [language] version of the document" and click "Create Document" (see screenshot). The system will create a document for both English and the indicated language. (Check for pop-up blockers if it doesn't appear.) Both versions will save to the student's Documents library.
