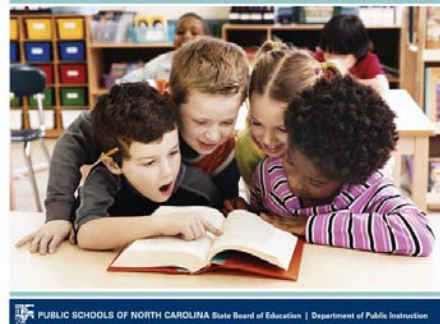

NC School Jobs for Charters

The North Carolina Department of Instruction is pleased to announce that we are in the process of implementing a new Applicant Tracking system for use by North Carolina's school districts. This project is underway and we expect to begin to work with Charters in early Q2, 2016.

The system selected for our new applicant tracking solution is TeacherMatch's Intelliglance. This system can be used to post jobs, have applicants apply for jobs, and to select the top candidates that apply for any given job posted. In conjunction with the TeacherMatch rollout a coordinated communications plan will be forthcoming that is being designed by DPI's communication department, Troops for Teachers, UNCGA, the DPI project team, and by TeacherMatch. We expect the coordinated communications plan to attract a greater pool of candidates that would be otherwise identified.

Look for more communications on this project in early 2016 and we look forward to working with all Charters interested in using this system in the future.
