#### Cap on State Funds used for Individual Salaries in Charter Schools – New Legislation!!

Effective July 1, 2015, Session law 2015-241 Section 6.26 caps the state funded portion of an individual's salary paid by a nonprofit organization receiving State funds at \$120,000. This provision applies to charter schools. All charter schools should ensure that employees being paid more than \$120,000 in the fiscal year receive the excess amount from local funds. #### **EVAAS Correction for Teacher and Administrator Evaluation Dashboards**

The NCDPI Education Effectiveness section has received reports from across the state that teachers' and school administrators' SAS-EVAAS (EVAAS) evaluation dashboards have been assigned to the wrong schools and/or districts. The issue resulted from multiple site assignments in the evaluation data from TNL. NCDPI and EVAAS will correct these incorrect assignments for the entire system in January. In order to complete the system update, we need charters and districts to collect a list of their teachers and school administrators who have an incorrect assignment.

Charters and districts should submit one correction spreadsheet directly to EVAAS at evaas\_support@sas.com. Outlined below are the steps to follow:

- Save the attached spreadsheet and append the name with your charter or district code (e.g., Alamance-Burlington would name the file "Incorrect Assignment Worksheet\_010").
- Submit the attached spreadsheet for your charter or district with zeros in the first three columns
  if you have no corrections (you need to put 10 zeros in the first column and six zeros in each of
  the other two columns).
- Include three pieces of information on the spreadsheet: the employee's state UID only (10 digits), the current (incorrect) school assignment in EVAAS, and the correct school assignment for the employee.
- Update PowerSchool after requesting the correct school assignment for the employee.
- Submit the attached spreadsheet by the end of the day on **December 31, 2015 to** <a href="mailto:evaas\_support@sas.com">evaas\_support@sas.com</a>.
