Register Now! Last Round of 2019-20 Home Base Meet-Ups

AIG Spring Headcount Collection

Recently, we gathered input about the AIG Headcount collection date to determine the needs of districts and participating charters. While many impacted expressed feeling prepared to move forward with our usual April collection, many others are facing significant access issues that would impede their ability to report the headcount accurately using our usual window. Therefore, we have decided to **move the AIG Spring Headcount submission window back to June 1 - June 15, 2020 for this year due to the COVID-19 impact on schools and districts.** It is imperative to note that with this late window so close to



many end of year processes, we will not have any flexibility to extend the deadline or re-open district instances to fix data. With this later window, we will need all data approved at both the school and LEA level no later than June 15, 2020.



State Approved Grading Policy (K-11) and Documentation

On April 23rd, the State Board of Education passed a <u>new policy for</u> <u>grading</u> students in grades K-11. The Digital Teaching and Learning Home Base Team is currently developing documentation to meet the new policy. We understand the urgent need for this documentation and are working diligently to provide in a timely manner.

Understanding GPA Calculations with .5 Credits

Last week, the Home Base team shared resources with guidance on COVID-19 grading for seniors. Since then, several questions have surfaced on how the GPA calculates with 0.5 credits. In order to assist with the understanding of GPAs, we have created the <u>Understanding GPA QRD</u>. It is designed to aid you in assisting your stakeholders on how the GPA calculation works. PowerSchool Field Word Change

As part of last weekend's 19.11.0.2 PowerSchool upgrade, the field "**Gender**" was changed to display as "**Sex**" for the Student, Staff and Contact *Gender* fields. See the examples below:

Previous Student Demographic screen display:

New Student Demographic Display in version 19.11.0.2:

Please note: *this is only a display change* on the front end and the field name will remain as **"Gender"** in the database for exporting/importing records. Therefore, when running exports out of PowerSchool, make sure to change your headers from "Gender" to "Sex." An example of this is below from class lists.

Please make sure to review your exports and change the header from "Gender" to "Sex." The header changes will be automated at a later date.

Looking for Online PD Credits?

NC Administrators and Staff may be researching the <u>NC Educator</u> <u>Effectiveness System</u> PD for Staff to complete while working remote. **NOTE:** Not all staff have access to this online system.



The Educator Effectiveness Department created courses listed here: <u>rt3nc.org</u>. These online professional modules are only available in NCDPI's Home Base/NCEES system. Access to online PD in the Home Base system is managed through an active employee ID Number, so only current employees of North Carolina public school districts or charter schools can access Home Base. There is no mechanism for others to access and use the educator resources housed in the Home Base system.

What follows are suggested PD Resources for CEU credits, not all are endorsed by NCDPI. DPI Open Access Modules are free, the rest may have a cost. Staff should follow local PSU guidelines and policies to obtain approval for taking PD outside that are offered locally.
