Coordinators and data managers, please remind your finance officers and charter school directors that the Home Base Opt-in Process is open until **June 15, 2020**. Any PSU that does not opt into Home Base for the 2020-2021 school year will lose access to Schoolnet and the NCEES PD Office Component.

Grading Rules for 2019-20 School Year

The current 2019-2020 school year is in effect until **June 30, 2020**. Therefore, the grading rules associated with 2019-2020 school year still apply until **June 30, 2020**. Any grade that a student receives in summer school will follow the State Board of Education grading policy for COVID-19.





AIG Spring Headcount Collection

Please be reminded that the AIG Spring Headcount submission window was moved to **June 1 - June 15, 2020** for this year due to the COVID-19 impact on schools and districts. It is imperative to note that with this late window so close to many end of year processes, we will not have any flexibility to extend the deadline or re-open district

instances to fix data. With this later window, we will need all data approved at both the school and LEA level no later than June 15, 2020.

-9 (XG) Update

The deployment of -9 (XG) into the NC PowerSchool instances was unsuccessful. PowerSchool is investigating the issue and plans to push it out as soon as they discovery what went wrong.

Common Sense has made the task simple for parents by researching videos, movies/TV, books, apps and music. The site is family oriented and the material is for ages ranging from toddler to young adults (age 18).

Learn how they rate and review

Common Sense Media rates TV shows, books, and music. *Their vision for media is: Families taking charge of their digital choices.*

Common Sense Education supports K-12 schools. According to the site, Their Digital Citizenship Curriculum prepares students with lifelong habits and skills. They offer support for teachers with training and recognition, and engage families and communities with helpful tips and tools. Their vision for education is, *"Students thriving as learners, leaders, and citizens in the digital age".*

Common Sense Kids Action works together with policymakers, business leaders as well as advocates to ensure that all kids can succeed. Their purpose is to assure that parents and educators are informed and up to date in the world of technology. *Their vision for kids' action is, "Technology that works to support families and society"*.

There are so many options on the site to filter through. First, you can filter by age. Next, the Entertainment section consists of over 10,000 movies, 4800 games, 4600 apps., 1311 websites, 6800 TV shows and close to 6000 books to choose/filter. The music genre spans from children's music, hip hop, christian rock, adult contemporary, rap, indie rock, punk rock, etc., etc., etc. Topics include cars and trucks, dinosaurs, magic and fantasy, superheroes, sports and martial arts. The list goes on and on. There is truly something for everybody. There is even a section recommended by other parents and sites that are popular with kids.

There are 3 tabs located at the top of the page: For Parents, For Educators and For Advocates

For Parents – Under this section, parents can see reviews for shows, books, etc., before their child watches it. There is also a parenting podcast called, " Parent Trapped by Ann Marie Baldonado", that discusses life, work, and learning with kids at home.


For Educators – This section includes a featured resource segment that focuses on topics that educators may want to discuss in the classroom. For example, because this is an election year, one of the featured resources provides the teacher with news and media literacy to enable them to discuss the election more in detail and at a level that the students will understand.

For Advocates – This section gives a briefing of how common-sense is advocating for kids today.
