PS Coordinators: Set Class Rank Recalculation Frequency to Manual

At the last Home Base Meet-ups, presenters shared that NCDPI was suggesting that LEAs set their recalculation frequency to "Manually". Complete details as to why were not available at the time and many LEAs made no change to their setup. **This is a very urgent matter and we are providing reasoning in this communication.**

When the calculations run daily, each Rank/GPA is calculated for every student in that school. For example, a High School that has a little over 1300 students and 4 different Ranks/GPAs, will write approximately 5200 records to the S_NC_HIST_RANK table nightly. Over time this adds up. Just for this one school, there are over 10.5 million records in the table. Once you multiple that by the number of schools in the district or state, this table becomes almost unusable. Performance is slowed for everyone in the district that runs a process against the table. In addition, any school can set this frequency so we are seeing the graduated, elementary, and middle schools with Ranks/GPAs in this table. This only adds to the number of records and performance issues.

NCDPI is working with PowerSchool to put a permanent fix in place. However, we can not complete that work as long as this many records continue to be created every night. We are asking that all districts change the recalculation frequency for all schools to "Manually" prior to the February 9 maintenance weekend. Instructions on how to make these changes can be found in the [Class Rank QRD](#). Any districts who are still set to anything other than "Manually" on February 9 will be changed by DPI. Once the work is complete, we will send out another communication informing LEAs that the setting can be changed back.

New 'TR' Code to be Used to Identify Transfer Courses

The PowerSchool Team is working with Accountability to create a simplified process that will help track transfer credits for testing purposes. This process will eliminate the need to use the 'S' exemption code.

PowerSchool Coordinators and Data Managers are NOT being asked to go back and change any current records. However, moving forward LEAs should begin entering "TR" in the "Credit Type" field that is associated with transfer courses under the student's Historical Grades screen. The Historical Grades QRD is currently being updated and will be shared in next week's newsletter.

The primary purpose of this new data entry requirement is to reduce the burden on PS data managers when a student comes from out-of-state, home school or private school and is granted credit for a course.

In the past, for school accountability purposes, if a student was granted credit in a course with an End-of-Course (EOC) exam the data manager was required to enter an 'S' code for the associated EOC on the student's testing history page. Accountability will now use the 'TR' data entry to signify credit for the associated EOC in these cases.




The Heritage Calendar: Celebrating the NC African-American Experience
