DIT Patching

The NC Department of Information Technology (DIT) will be performing monthly Linux patching, including the UID System servers, this Sunday, February 24, 2019, between 4:00 a.m. and 12:00 p.m. The Staff and Student UID systems will be unavailable during this time. Therefore, please do not enroll, transfer and/or update student demographic information in PowerSchool during this period.

CCES Conference

The Connecting Communities of Education Stakeholders Conference is less than a month away! This conference aims to provide support staff with professional learning and resources for the daily operations and needs of school communities.

PowerSchool Sessions

- **TR and TR7 codes** - Demonstrates how the T code is written automatically.
- **Getting Through the Day... Step-by-Step!** - Participants will receive step-by-step instructions for daily tasks such as: entry and withdrawal of students, daily attendance and report card processes. Participants will also have access to quick reference checklists for entry/withdrawal.
- **System Administrator: Security Settings** - Securing your PowerSchool system should be at the top of your to-do list. Begin by learning how to establish security groups and user access roles to define overall security access.

Schoolnet Sessions

- **The Basic Ins and Outs of School Net Manual Test Building** - Participants will learn the basics of Schoolnet and learn how to develop a Manual Test.
- **Schoolnet: The Recipe for PEPs and IEPs** - In this session, the presenter will show teachers how to find data in Schoolnet to be used in IEP and PEP meetings. Come on out to learn about a "recipe for student success!"
- **Creating and Monitoring Schoolnet Assessments** - Join us as we work through developing a Schoolnet pre-assessment to match a unit, analyzing the data from the assessment, grouping students and developing appropriate leveled assignments based on the identified groups.

Unified Talent (NCEES) Sessions

- **Generational Diversity** - This session focuses on how to capitalize on Millennials and Gen-Xers' strengths.
- **Coaching Teachers Using Teacher-Led Conferences** - It's time to rethink the way we conduct coaching conversations with teachers for improvement. Teacher-Led Conferences will minimize the burden on administrators and provide richer more relevant feedback opportunities to support growth for teachers.
- **Understanding the Teacher Evaluation Rubric** - This workshop will use a hands-on approach to confront the complexity of Teacher Evaluation Rubric and Process expectations, and consider ways the structure of the Teacher Evaluation Rubric supports teacher growth and improvement.
