## **Course Code Update**

Revised Master Lists have been published at: <a href="http://www.nc-sis.org/courses.html">http://www.nc-sis.org/courses.html</a>. These lists reflect a change to the CTE Career and College Promise (CCP) courses. A new system, based on the information below, will be phased in from the Spring of 2017 through the 2017-2018 SY.

#### New CTE CCP Coding System

- Continue to use the existing unique codes for CTE CCP courses that are part of the Comprehensive Articulation Agreement.
- 2. Continue to use the existing unique codes for CTE CCP courses that have been designated as honors.
- Begin using generic cluster codes for courses that do not have assigned unique codes (see instructions below).
- 4. Use generic cluster codes or existing unique codes for non-CAA or non-honors courses for which unique codes have already been established. The unique codes will be inactivated at the end of the 2017-2018 SY. All non-CAA and non-honors courses will use the generic cluster codes beginning with the 2018-19 SY.

This change was made to allow LEAs to count the courses in appropriate clusters based on the local agreement, not on a state setting. By using this system, you should avoid having to make overrides on the student academics screen for the course to count correctly. This will also allow students to be enrolled in CCP courses without a delay waiting for the course to be set up.

#### CTE Generic Course Code Scheduling Guidance

A. Courses must be part of a local CTE Pathway agreement between the local education agency and a community college. At the time the course is added to the agreement, the LEA and Community College should determine how it counts in a cluster based on the approved CTE Pathway.

- 1. As a general rule, courses must have a required community college prerequisite to count as Level 2 (completer) courses.
- 2. Community College courses must count as Level 1 or Level 2. Enhancement courses are not available.

- 3. Non-technical courses cannot count in a cluster even if they are in the CTE Pathway.
- B. The person enrolling students should select the course code for the appropriate cluster and level.
  - 1. Generic CTE CCP courses have "WC" in the first two digits and "2X" in the fifth and sixth digits.
  - 2. Use the Community College course code (with no spaces) and the Community College title as the local description.
  - If the course meets state board requirements for greater than 1 credit, the LEA can change the
    credits shown in the credits field. You MUST follow the state board policy below, which is based
    on the total semester hours given for the course in the Community College Combined Course
    Catalog.
    - a. 1-4 semester hours, 1 credit
    - b. 5-8 semester hours, 2 credits
    - c. 9 or more semester hours, 3 credits
    - d. If the course has a separate lab component, the semester hours for the lab course and the regular course should be combined to determine the credit.
    - e. If the course is taught in multiple parts, the credit can be distributed among the parts as appropriate. The sum of the credit of all parts must equal the total credit in the course as shown in the Combined Course Catalog.
- C. LEAs are subject to audit to ensure course coding is done correctly

Happy New Year to those working on the Office of Civil Rights Data Collection! While our first week back was a short one, a number of districts really dug into the PowerSchool CRDC Preview reports and took a good hard look at the data. A big 'Thank you!' to all those who have reported issues.

Another big 'Thank you!' goes to the staff in the state who are helping to support their peers on this collection using the Grads360 CRDC NC Workgroup. The collaboration is inspiring! For those of you working on the collection who may not be aware of or have access to the group, the OCR NC workgroup offers a chance to review previously conducted webinars, access Federal and NC specific documents (all of which are provided on the NC DPI OCR website) and create discussions that reach all members of the workgroup. #### Fixes Pending the February 1 PowerSchool CRDC Preview Report Submission End Date:

It is the goal of the NC DPI to complete fixes prior to the current PowerSchool CRDC Preview Report Submission End Date of February 1, 2017. Please continue to review your data and report any issues ASAP.

- AP Math and AP Sciences are also counted in the category of AP Other
- Algebra I and Geometry classes are counted in MS and HS math class count categories for schools with

grade levels 6-12

- AIG students with any records with a withdraw date after 10/1/2015 are not counted
- CRDC PowerSchool Preview Report Part 2 is counting the subgroup LEP incorrectly
- CRDC PowerSchool Preview Report Part 1 is indicating 'Yes' to Preschool when CRDC School Screen

indicates 'No.'

#### **Deployed Fixes:**

The NC DPI made updates to the CRDC PowerSchool Preview Reports and screens during the winter break. The following updates were made in a special December 27th release. Please remember that the reports must be re-run to capture the changes:

- Students that passed Algebra I with a percent value greater than or equal to 59.5 are now counted in CRDC

Part 2

- Students that passed Algebra I with a P in the grade are now counted in CRDC Part 2
- Students that passed Algebra I at the middle school level are accurately reported either as grade 7 or grade 8
- On the CRDC LEA page, the query for the number of students that are less than two or between the ages of 3 and 5, no longer includes students from the DPI FTE school or the graduate school
- The CRDC Part 1 collection is updated to use the School\_Type\_Eddie field for identifying alternative

schools

- The CRDC Part 1 collection is updated to accurately report Algebra I and Geometry classes taught at the

middle school only on the questions for the middle school. They are no longer counted on the high school

question for schools with traditional middle school grade levels

#### **CRDC External Data Not in PowerSchool**

The external data file is currently in progress. The NC DPI is currently working to complete the Certified Teacher data prior to publishing. As a reminder, external data includes Expenditure, FTE and Certified Teacher data. Data files and supporting documentation will be located at the following

Teacher Absentee data must be collected and updated in the Federal submission Portal by the LEAs after the NC DPI data uploads.

Session times are from 1 p.m. - 3 p.m. These two hour sessions will provide reminders and status updates on the progress of the PowerSchool CRDC Preview reports as well as discuss the NC DPI schedule for upload to the Federal Submission Portal. Users will also have the opportunity to ask about PowerSchool functional processes. Note: The project timelines are subject to change.

The first portion of the webinar will focus on the project, the second segment will be dependent on attendee questions.
