PowerSchool Support Reminders

In case You Missed It!

Effective July 15th, PowerSchool Support provides all technical support for your SIS instance.

Three ways to request PowerSchool support:

- CHAT: Chat support will be available for you through the PowerSchool Community at: <u>Launch Chat Support</u>
- 2. CASE: Submit a case via the PS PORTAL: https://help.powerschool.com/
- 3. CALL: 1-855-339-4790 NEW! This is a dedicated NC Support line

* If you are reporting an outage or performance issue (P0 or P1), please CALL or use CHAT. This insures immediate attention by PowerSchool support.

PowerSchool Upgrade - version 19.4.2

PowerSchool Phase I upgrade to version 19.4.2.0 will occur the weekend of August 16-19. PowerSchool will be brought down on Friday, August 16, 2019 at 5 p.m. and returned to service no later than Monday, August 19, 2019 at 6 a.m.

In order to be fully prepared, please consider completing the following items prior to the upgrade on August 16, 2019.

- Run any AutoComm/AutoSend which are currently using FTP because FTP will not be available after the upgrade. This includes third party applications your Public School Unit (LEAs/Charters) may use.
- Upgrade your AutoComm/AutoSend from FTP to SFTP
 - Save/Print any of the following you may need for Open F

House, return of Teachers, etc. (These are just

a sampling of items)

- o Homeroom Lists
- Class Rosters
- Student Schedules
- Student Parent Contacts (Reports>NCDPI Reports>Auto Dialer Extracts)
- Progress Reports (Year-round schools)
- Report Cards (Year-round schools)

PowerSchool Phase II upgrade, which will improve the functionality of contacts, will occur January 2020. More detailed communications addressing the impact of the new contact functionality will be forthcoming.



Graduation Data Verification Report - Deadline Extended to July 31

All LEAs must run the GDV Report, even if you did not make corrections/edits. See message below.

DPI and PowerSchool have received several requests for clarification on the GDV report that was originally due today, July 26. We are offering the following information in hopes that it will bring clarity to the report, specifically regarding summer graduates. In addition, **we are extending the GDV deadline to July 31**. Even if you have already approved your district's GDV report, after reading the

following information, you may want to go back and make corrections to graduate records and submit again.

In order for 2019 summer graduates to be included in this year's cohort graduation rate, students who graduate between July 1, 2019 and July 15, 2019, must have a graduation date that is June 30, 2019 or earlier. As the current report is designed, all graduates with a diploma issued/granted date of July 1, 2019 or after are flowing into the

2019-20 GDV. This will be changed to include the fifteen day extension for the 2019-2020 report, but for now you must modify the diploma dates for your summer graduates to be captured. *This year's GDV report should include all students with a diploma date of July 1, 2018- June 30, 2019.* You may ignore the fact that this year's summer graduates will not be labeled as such on the current report.

Public School Units experiencing further issues with the GDV report should contact PowerSchool Support.



EDDIE Sync Update

NCDPI is aware that EDDIE and PowerSchool are still out of sync. PowerSchool Hosting identified the problem yesterday, but could not make the change prior to the 8pm nightly process. NCDPI has asked PowerSchool to load the latest file prior to the close of business today. DPI and PowerSchool staff will monitor this process over the weekend in hopes of having both applications in sync by Monday morning. We will continue to keep you informed as we learn more. At this time, there is no need to contact PowerSchool or Home Base Support about these sync errors.

As a result of the 2018 acquisition of the North Carolina Educator Effectiveness System (NCEES) solution by PowerSchool, NCDPI has moved vendor maintenance and support of NCEES directly to PowerSchool by adding it to the main PowerSchool contract effective 7/1/2019. This is a contractual change and has no impact on the usage, implementation or support for the system.

NCEES district admins should continue to submit system issues to the ServiceNow Support Desk until further notice from NCDPI.
