# 2015-16 EOY

This year's process completed Wednesday, at 3 p.m., with the reopening of the final Home Base applications. All applications are currently up and available for school year 2016-2017 business. # **Post-EOY Recommendations**

**Reset Section Meetings** 

PowerSchool has identified a known issue with the commit process that can affect the section meeting table. During the commit process, this table is cleared for the scheduling year and repopulated with data contained in the scheduling scenario. Each school's commit process is intended to only clear and repopulate that school's data. It has been found that in some cases the commit for a single school clears the entire table and repopulates only that school's data. This can cause several issues within PowerSchool including: periods not displaying in correct order, manually scheduling student screen does not render correctly, and student/teacher schedules to appear incomplete.

This issue can be corrected at either the LEA (run for entire district) or school (single school correction) level through the special operation (System>Special Operations) Reset Section Meetings. The following settings must be used to run this operation:

Param 1: 2016 (to indicate the 2016-2017 school year)

Param 2: blank

Code: resetsm (all lower case)

This operation will repopulate the section meeting table data for the LEA/School (depending where ran) to correct the issues mentioned above.

#### **Calendar Setup**

It is also recommended that each LEA/School complete the calendar setup as quickly as possible. Incomplete calendars can also adversely affect displays and functionality within PowerSchool. For student schedules to render correctly, the first and last day of each term must be set up within the school calendar and one of each rotation day must exist in each term. Complete calendar setup is required for PMR and other reports to function properly.

#### **Class Counts**

The enrollment number displayed for a section can also be adversely affected by the section meeting table issue mentioned above. After completing the reset section meeting special operation it is also recommended that the LEA/school run the special operation Reset Class Counts (system>special operations>Reset Class Counts). The school calendar must be setup completely before running Reset Class Counts in order for the system to correctly display the enrollment number. Also, as scheduling of students resumes, this operation can be re-run periodically to ensure that the system display is current based on schedule changes.

#### **Keynote Monitor User**

All LEAs should have a staff user with the name "Keynote Monitor." This user is utilized by PowerSchool to perform system monitoring through their automated utility. The user's access should always be active. During EOY and other times, the need arises for coordinators to "lock out" users. Please be sure that these "lock outs" do not revoke the access for the Keynote Monitor. Doing so impedes the ability of PowerSchool to verify that the system is performing up to expectation. Further, when this user access is revoked, it shows as a "false positive" on the monitoring tool. As part of the effort to streamline system monitoring and support, we appreciate attention to this detail.

# **Next Maintenance Weekend**

The next Home Base maintenance weekend is scheduled for Friday, July 15 through Sunday, July 17. Maintenance will be performed only on the PowerSchool application. If this should change, a message will be communicated.

PowerSchool will shut down Friday, at approximately 5:00 p.m. Once maintenance is completed, a message will be sent to notify users that the system is up and available for use. PowerSchool will be returned to service no later than 6:00 a.m., Monday morning. If a delay in bringing up the system should occur, users will be notified.

# Reminder: New Remedy System Goes Live July 15

The NCDPI and the Technology Support Center are pleased to announce that we will be converting to the new 'Remedy on Demand' support ticketing system beginning Friday morning, July 15. Some important user details and highlights include:

# **Course Code Update**

A revised Course Code Master List has been posted to the NC-SIS website. Please note the following updates:

### **NC Math Courses**

Following an extensive standards review and revision process, the North Carolina State Board of Education (SBE) approved new high school math standards on June 2, 2016 for Math I, Math II, and

Math III. The new standards will be fully implemented during the 2016-17 school year and will now be named **NC Math 1**, **NC Math 2**, and **NC Math 3**. New course codes will be available in PowerSchool on July 8, 2016, titled NC Math 1, NC Math 2, and NC Math 3. Beginning with the 2016-17 school year, districts are to no longer use the course codes for the old standards for Math I, Math II and Math III. The <u>Course Coding Guidance for New NC Math Courses</u> memo provides greater details about this update.

# Career and Technical Education (CTE) Courses

This release includes new course codes for Career and College Promise courses that are part of a technical pathway. In addition, the original course codes for exploratory middle grades courses are made unavailable. Beginning with Fall 2016, students must be enrolled in the appropriate "courselets" for the exploratory middle grades courses.
