## **NC PowerSchool Updates this Weekend**

Resolutions to the following issues will be deployed into PowerSchool this Friday, June 2, 2017, during our normal Friday night Restart Process. Users should experience very little, if any, impact at all. These changes are critical for the completion of EOY.

## 1. Issue: Unable to set courses to a value of 0.5

Resolution: Users will be able to successfully update the added value field within the Edit Stored Grade Screen. Additionally, the Change history is also successfully updated within the Edit Stored Grade screen.

## 2. Issue: Course flags missing the associated 'U'

Resolution: Course flags for course numbers 11422Y0 and 22095X0 will correctly appear on the NC Official Transcript as "U" Flags after being correctly mapped to UNC requirements.

### 3. Issue: PowerSchool web call to state student UID system

Resolution: Updates to existing Hispanic students within PowerSchool from Hispanic to Non=Hispanic will correctly display within cedarstest.schools.nc.gov/studentid.

**User Process:** 

- User updates the student Ethnicity on the General Demographics screen radio button from Yes to No for the following item: Is the student Hispanic or Latino?
- User clicks the Submit button.

#### 4. Issue: GPA not calculating on AE report

Resolution: GPA calculation will begin to appear on the AE report.

### 5. Issue: Renew date for sports physical does not appear correctly on AE report

Resolution: The correct date for renewing students' sports physical will appear on the Athletic Eligibility report.

## New Functionality to Assist with Approving 9th Month PMR

New functionality will be applied to PowerSchool this weekend. This functionality will allow schools who are permitted calendar flexibility based on the Disaster Recovery Act of 2016 and are reporting less than 16 days on the 9th month PMR interval days' screen to approve their 9th month PMR.

#### **PowerTeacher Pro Resources**


Spring training for PowerTeacher Pro (Gradebook) is complete. Another round of training sessions is being planned for July - dates coming soon. As we get closer to the implementation of PowerTeacher Pro, these are resources that you may find helpful: Keys to a successful PowerTeacher Pro Rollout will help in ensuring your rollout is successful and your teachers are on board and happy. We have also shared that Canvas has implemented a new solution for provisioning/rostering with their SIS integration platform. This new solution, specifically leveraging SIF 2.0 technology, transfers your PowerSchool data into Canvas with bulk uploads and/or near real-time events.
