DIT Linux Patching on UID Servers - Saturday, March 18, 2017

The NC Department of Information Technology will be performing their monthly Linux services patching, including the Student and Staff UID servers, this Saturday, March 18, 2017, between 4:00 a.m. and 9:00 am. The

Staff and Student UID systems will be unavailable during this time. Therefore, please do not enroll, transfer and/or update student demographic information in PowerSchool during this period.



PowerTeacher Pro Implementation Plan

Over the past two months, a group of representatives from various parts of the state worked together to develop an implementation plan for the release of PowerTeacher Pro. You may access the full plan here.

In addition to the development of the implementation plan, we recently administered a statewide survey regarding participation in Cohort I of the PowerTeacher Pro release. This first Cohort will be rolling out PowerTeacher Pro at the start of the 2017-18 school year and will soon begin receiving targeted professional development and technical assistance. Exempt Flag for Math I

flag is located on the NC Information --> DPI Academic Page. The Math I Exempt flag will be used for students who are exempt from Math I pursuant legislative mandate GS115C-81(b) which allows for students with a Specific Learning Disability in math to be exempted from Math I as a graduation requirement if their learning disability prevents them from mastering Math I. Implementing this flag in PowerSchool provides an easier way of tracking and monitoring the usage of this exemption for

PowerScheduler Regional Working Sessions (Build & Load, Load Only)

**Please note, all registration information is subject to North Carolina Public Records Law.

Attendees must be an employee of a North Carolina public school. Management companies and its employees are not permitted to attend.

The "Build and Load" session is designed for schools building a master schedule using PowerScheduler. Prior to attending this session, schools MUST complete at minimum, steps A-H in the "PowerScheduler: Prepare to Build" workbook. Having the build data validated and errors cleared before attending is recommended. Schools will work with their scheduling teams to complete the build and load processes to the extent that time allows.

The "Load Only" session is designed for schools planning to copy their master schedule, and loading students into courses. Prior to attending this session, schools MUST complete at minimum, steps A-G in the "PowerScheduler: Load Process". Schools will work with their scheduling teams to complete the load processes to the extent that time allows.

These workshops are not intended to be a training session. They are hands-on work sessions; schools should plan to send all personnel needed to complete the build and load processes and/or load processes. Up to 4 people per school may attend.

Only the LEA/Charter SIS Coordinator or designee may register their schools for sessions. Note, only 1 school per LEA may sign up per regional "Build and Load" and "Load Only" sessions. For example, an LEA may send up to three schools per week (one school Monday-Tuesday Build and Load, one school Wednesday for Load Only, and one school Thursday-Friday Build and Load). It is only necessary to create one registration for each school - not one for each person that may attend. Each registration allows 4 people from that school to attend.

Attendees are to bring a laptop to each session and make sure that the latest PowerScheduler Engine is Loaded before coming to the session.

**Please note, NCDPI has the right to combine sessions if not enough attendees register.

Sessions run 9 a.m. - 4 p.m. each day with lunch on your own.

Items that must be resolved by the PowerSchool vendor prior to certification

Items that require fixes to PowerSchool also require the CRDC Preview reports to be re-run. The solution will be implemented in PowerSchool beginning at 8 p.m. this evening. The PowerSchool CRDC Part 1 re-run will be completed during this weekend by the vendor.

The NC DPI will notify the state once these corrections are made and the data has been uploaded to the Federal Submission Portal.

• AP enrollment counts in Math, Science and Other categories are counting courses based on SY 13-14 and SY 15-16 course mapping logic.

Items resolved the week of 3/10/2017

Note: The items below did not create errors in the Federal Submission Portal.

- The Justice Facility table in the Federal Submission portal has been flagged as 'not required' for all LEAs and Charters except for the Department of Juvenile Justice. The data has been removed from this table in the Federal Portal.
- Two elements in the EXPD table were either misaligned or missed:

Number of personnel Support Services Staff funded with FEDERAL, STATE, and LOCAL funds and the amount of salary expenditures

School Administration Staff funded with FEDERAL, STATE, and LOCAL funds and the amount of salary expenditures
