## Next Maintenance for Home Base and NCDIT

The next Home Base maintenance weekend is scheduled for Friday, May 19 through Sunday, May 21, 2017. At this time, PowerSchool is the only Home Base application scheduled for maintenance.

PowerSchool will be brought down Friday evening, May 19 at 5 p.m. and returned to service no later than Monday, May 22 at 6 a.m. Once maintenance is completed, a message will be sent to notify users that the system is up and

available for use. If there is a delay in bringing up the application, users will be notified as well.

The NC Department of Information Technology (NCDIT) will be performing their monthly Linux services patching, including the UID Systems servers, this Sunday, May 21, 2017, between 4:00 a.m. and 12:00 p.m. The Staff and Student UID systems will be unavailable during this time. Therefore, please do not enroll, transfer and/or update student demographic information in PowerSchool during this period.

## Remedy Support System Maintenance

On Sunday, May 21, 2017, from 1 a.m. -7 a.m. EDT, the NCDIT will be performing planned maintenance on the Remedy OnDemand ticketing system and customer web portal. During this time frame, the system will be unavailable. If a delay in bringing up the system should occur, users will be notified.





## **EOY Reminders**

The 2016-2017 EOY Process for Home Base will start **Friday**, **June 30**, **2017**, **at 5:00 p.m.** All work will be completed by **6:00 a.m.**, **Monday**, **July 10**, **2017**. Users will be notified when the system is returned to service. Make sure all required state compliance reports are completed no later than **June 30 at 5:00 p.m**. Delays in these reports will impede the state processing and increase downtime.

Also, please be reminded that all LEAs and charter schools must be ready to run their EOY process by **8:00 a.m.**, **Saturday**, **July 1**, **2017**, regardless of their end date. Running EOY anytime earlier will cause issues and could jeopardize the state EOY timeline.

LEA coordinators or designated EOY contacts will be responsible for running EOY in their PowerSchool instance. DPI will be monitoring the progress throughout the day to ensure completion of EOY for all instances within a timely manner on July 1, 2017. Further details will be provided soon.

#### **Data Validations:**

At this time, users are encouraged to begin validating their EOY data. Completing these validations is a critical step in completing the EOY process. Remember, data must be checked regularly as students continue to enroll/transfer in. NCDPI recommends running the EOY validations frequently leading up to EOY.

The EOY validation can be run from the LEA level within PowerSchool.

(System > End of Year Process). Be sure to select one of the two validation options: "Perform EOY Validation" or "Perform EOY Validation and make any students with issues the current selection."

MidYear/Early Graduates:



## PowerTeacher Pro Update

Training for the new PowerTeacher Pro (Gradebook) update has begun and is going well. There are approximately 500 educators from 91 districts and charter schools attending 16 full day teacher and 12 half day administrator training sessions in all 8 regions.
