NC PowerSchool Instances Excluded from Maintenance Window this Weekend

Some of our NC PowerSchool users may have received a tech note on Monday, May 22 from PowerSchool Hosting regarding a maintenance window this weekend. Please be advised that this tech note does <u>not</u> pertain to North Carolina instances. The infrastructure supporting the hosted North Carolina PowerSchool sites are already patched and thus, will <u>not</u> be taken down for service.

End-of-Year Response to Feedback

Due to recent questions regarding End-of-Year, NCDPI would like to provide more feedback about the process.

The End-of-Year (EOY) Process is used to close out the current school year and transfer all students to the grade level and school that each will be attending in the upcoming school year. The start date for EOY is based on the last operational day of the month for school districts. This year, the last day of the fiscal year is June 30 which, unlike recent previous years, happens to fall on a Friday. Timing is critical. Year-round track schools are operating through the last school business day of June. It is also essential that systems are operational as soon as possible after EOY so that teachers and administrators in year-round schools will have the opportunity to ensure systems and gradebooks are ready for use. This provides clear justification as to why the EOY dates are so specific and there is little room for change. It is always our goal to minimize the downtime.

The actual EOY process is quick. Districts determine their primary and secondary contacts in the event problems arise so that NCDPI has a contact. Prior to EOY, districts should ensure that data has been cleansed and each student has an identified next school and next grade (EOY will not run properly if these steps are missed for any single student).

There is an entire web page dedicated to the <u>EOY process</u>. The process has evolved over time, but this is the essence of it. A new EOY Guide will be published next week.

Who is Responsible	Action Item
LEA	Validate data - this step is critical. EOY will not run if validation errors are not cleaned
LEA	Communicate completion to DPI (for districts that execute the process)
NCDPI	Verify validation is complete for all LEAs (this is a second check to make sure there are no validation errors)
NCDPI / PowerSchool	Shut-down on last weekday of the month. (PowerSchool takes backup of systems)
LEA or NCDPI	Run EOY on 8 a.m. of the morning following system backup (this part's easy) during shut-down
NCDPI / PowerSchool	Re-connect and initiate PowerSchool Instances (ODS)
NCDPI	Notify completion of EOY to LEAs
LEA	Validate data - quick spot check to determine if students were moved to next grade/school
NCDPI	Complete year end processes for state's integrated/dependent systems
NCDPI	Communicate systems up
LEA	Begin Post-EOY (SIS data review, updates and local system integration)

Start and end times are recorded. Run durations depend on LEA size. Average run times span between 30 seconds for small districts/charters and two hours for larger districts. Districts are asked to report run times to NCDPI. NCDPI works with the vendor to monitor districts that have not reported to identify and resolve any potential issues.

NCDPI can assist districts who have staffing issues and cannot execute EOY. Please log a ticket with the support center by June 9 if this should happen. Please be advised that NCDPI cannot validate district data. Local staff are closest to the data and would know expected outcomes.

NCDPI is committed to making the EOY process as quick as possible and will explore alternative approaches to EOY where possible.

The NCDPI Home Base staff is requesting all LEAs and charters to enter their End of Year Contacts (primary and backup) information



Schoolnet News

The Home Base staff are excited to announce an increase in Certica items in the Schoolnet item bank for the 2017-18 school year. New items will include:

- an expansion of English language arts and math progress checks into the middle grade levels (6-8);
- more than 500 new English language arts items with an emphasis on high Depth of Knowledge and technology enhanced items types;
- 500 new math items:
- 600 new science and social studies items; and
- 2,000 new trans-adapted Spanish items.



Further Roadmap Progress

- Continued expansion of all content areas with emphasis on high Depth of Knowledge and technology enhanced items. The specific areas of focus are being determined at this time.
- Tighter integration with AB connect focused on expanded searching capabilities including concept and topic-based searches.
