### **Home Base Maintenance Weekend**

The October 2018 Home Base Maintenance Weekend will take place Oct. 26-28. This maintenance was moved from its originally scheduled date of Oct. 12-15 to allow more time for the delivery of a complete version of Legislative Class Size Reporting, Phase I of Infield/Out-of-field, and the latest SADLS correction. In addition, the GDV report submission window will be modified during this maintenance period.

Maintenance will also be performed on the Schoolnet application. This maintenance includes an application upgrade to Schoolnet 20.0.5 which provides a permanent resolution for scoring glitches that

occurred last month. Additionally, EOC, EOG, DIBLES, and TRC scores from EOY of 2017-2018 will be loaded during the maintenance. The application will be taken off line at 5 p.m., and the update is estimated to take approximately one-hour.

NCDPI anticipates a much earlier than normal return to service date and time for the Home Base applications. Once maintenance is complete, the curtain will be lifted immediately.

All systems will be returned to service no later than 6 a.m. Monday, October 29. A message will be sent to notify users that the applications are up and available for use. If there is a delay in bringing up the applications, users will be notified.

## **DIT Monthly Patching**

The NC Department of Information Technology (DIT) will be performing monthly patching, including the UID System servers, this Sunday, October 28, 2018, between 4:00 a.m. and 12:00 p.m. The Staff and Student UID systems will be unavailable during this time. Therefore, please do not enroll, transfer and/or update student demographic information in PowerSchool during this period.





# **Hurricane Displacement Special Programs**

NCDPI is providing mechanisms to track students displaced by the recent hurricanes from both, in state as well as out of state. In order to collect this data in a timely manner, NCDPI plans to utilize the Special Programs page for this collection. NCDPI staff will be creating two special programs at the LEA level in PowerSchool. Those programs will be titled "Hurricane Florence Displacement" and "Hurricane Michael Displacement". Instructions on how to assign these special programs are covered on slides 6 through 8 in the Coordinators' Monthly Update webinar that was held Thursday, October 25.
