Course Code Guidance

College Courses Less Than 3 Semester Hours Credit

As a reminder, in certain circumstances, semester hour credit from community college courses may be combined in the same academic year to meet the minimum three semester credit hours to be awarded high school credit. The following types of dual enrollment college courses may be combined:



CTE courses on the same approved CTE Pathway: these courses should be coded with the generic
CTE pathway course codes (more information about these courses can be found at: http://www.nc-sis.org/Documents/course_information/CTECCPGuidanceDoc.pdf).

- Non-CTE courses, not on the CAA, but in the same content area: these courses should be coded
 with the non-weighted generic college course codes (more information about these courses can be
 found at: http://www.nc-sis.org/Documents/course information/Course Code Guidance.pdf).
- Non-CTE, Comprehensive Articulation Agreement (CAA) courses in the same content area: these
 courses should be coded with new "Combined CAA CCP" weighted generic course codes that can
 be found on the 2018-19SY Master List found at: http://www.nc-sis.org/courses.html.

When combining courses into one generic course code, the college subject abbreviations and course numbers should be placed in the "course name" field (also known as the long title or local title) in order to ensure accuracy on the transcript. For example, if MUS131 "Chorus I," MUS132 "Chorus II," and MUS231 "Chorus III" were combined, the course name should contain at a minimum "MUS131/MUS132/ MUS231." Additionally, local course code extensions (digits 8-10) may be added to help differentiate these courses locally.

Semester hour credits for community college courses are defined in the Common Course Library (CCL). This may be found at http://www.nccommunitycolleges.edu/academic-programs/combined-course-library. All course credit must be reflected in the CCL as the credit associated with that specific course, and shall not be the sum of lab and course hours. LEAs cannot define the semester credit hours based on local changes to the courses. For your reference, a list of CAA courses less than three semester hours is posted at www.nc-sis.org/courses.html.

Transferring Student Records

When transferring students from one school to another, please remember to follow the "Transfer Student Record Process". This step should be a part of every single enrollment, including "No Shows". Failure to follow this process breaks the chain of history for the student.

DIT Patching

Therefore, please do not enroll, transfer and/or update student demographic information in PowerSchool during this period.





SET Report Reminder

The Start-Time and End-Time (SET) Report was reopened last week to give LEAs and charters the opportunity to make any necessary corrections or modifications. Corrections must be in and reports submitted by today, **October 5**. LEAs and charters may refer to the QRD, <u>School Start-Times and End-Times</u>, for assistance.

Legislative Class Size



NCDPI requested PowerSchool to install the Fall version of the Legislative Class Size (LCS) over this past weekend so that coordinators could begin running these reports and submitting any issues to the support center. Several known existing issues that are expected to be fixed during the October Maintenance Weekend are shared below. In addition to these items, we are requesting designated PowerSchool coordinators to submit tickets of other issues they may find to the NCDPI Support Center by today, **October 5**. This submission request is not necessary for correcting your data; however, it will help us to troubleshoot problems that are state-wide. In most cases, problems that exist for one district will exist for all.

The items below are existing issues that have already been reported to PowerSchool; therefore, there is no need to report them again:

- LEA LEVEL REPORTS AT THIS TIME DO NOT RUN ANY REPORTS FROM THE LEA LEVEL.
 ONLY RUN FROM THE SCHOOL LEVEL. Running these reports from the LEA level will result
 in extreme performance issues and the reports will never load. PowerSchool is aware, and a
 fix is expected by October's maintenance.
- Submission dates Reports are showing a submission date of 9/30; that will be changed to a November date during October's maintenance. A script is being ran nightly to unlock these reports. Therefore, you do not need to submit a ticket if you accidentally approve a report.

- Exceptions report showing classes from invalid grade levels We are aware that the exceptions report is returning sections containing grade levels other than K, 1, 2, and 3. This has already been reported to PowerSchool. However, you should still see exceptions showing for K-3 if the classes are over max.
- Exceptions report not showing enrollment numbers or section numbers This has been reported to PowerSchool.
- Reports showing SectionID rather than Section Number While the calculations are supposed to
 be looking at the SectionID to identify unique sections, we've let PowerSchool know that it will be
 more helpful for coordinators to see the Section Number on the report screen. This is expected to be
 corrected.
- K-3 Average Report returning no results for some K-3 schools We realize that for many elementary/K-3 schools, the K-3 report is not showing any results. This has already been reported to PowerSchool.

Remember, there is no need to submit tickets for any items listed above. NCDPI will schedule an LCS webinar in the coming weeks, but for now please refer to the <u>latest slide deck</u> that was presented at the Summer Conference. Justin Conner, NC DPI SIS Analyst, is also currently working on a very detailed LCS Guide that will be shared later this week.



Updating School Calendars with Calendar Note

To ensure your state compliance reports are as accurate as possible, please remember to update your school calendars. NCDPI is being requested to report closures, delays and early dismissals as a result of Hurricane Florence for all schools. In order to provide accurate

information, NCDPI is requesting that a specific calendar note be added to all schools that experienced any closures, delays and/or early dismissals in preparation of and/or as a result of the storm. In addition to the steps provided in the <u>Calendar Change Process QRD</u>, we are asking that you type "Hurricane Florence" in the note section of each school's calendar setup for the days that were not in session due to the hurricane.

It is important that you adjust your calendar information in a timely manner once schools have reopened. This data was collected on Tuesday, October 2, and we found that the note field for some schools had not been updated to reflect the verbiage, "Hurricane Florence".

We realize that some schools may not be able to perform these updates at this time. Please update as soon as the information becomes available to you.
