A Solution for Missing Records in mClass

Some districts and charters have reported a problem with staff members not showing up in mClass. Amplify, the mClass vendor, has confirmed that the email address in mClass is a required field. Consequentially, if a record in the PowerSchool extract loaded into mClass is missing an email address, mClass will reject the record.



Solution: NCDPI pulls the staff data extract nightly. Please ensure the email address is present for each staff. Once the overnight process runs, the staff should appear in the mClass system. If you continue to have problems, please contact our NCDPI Technology Support Center by submitting a [Remedy](#) ticket.

Reopening of SET Report

The Start-Time and End-Time (SET) Report has been reopened to give LEAs and charters the opportunity to make any necessary corrections or modifications. At this time, 56 LEAs have not processed their SET time.

Updating School Calendar with Calendar Note

To ensure your state compliance reports are as accurate as possible, please remember to update your school calendars. NCDPI is being requested to report closures, delays and early dismissals as a result of Hurricane Florence for all schools. In order to provide accurate information, NCDPI is requesting that a specific calendar note be added to all schools that experienced any closures, delays and/or early dismissals in preparation of and/or as a result of the storm. In addition to the steps provided in the [Calendar Change Process QRD](#), we are asking that you type **"Hurricane Florence"** in the note section of each school's calendar setup for the days that were not in session due to the hurricane.



It is important that you adjust your calendar information in a timely manner once schools have reopened. This data will be collected on Tuesday, October 2, so please be sure to make your modifications prior to that date.

We realize that some schools may not be able to perform these updates at this time. Please update as soon as the information becomes available to you.
