 After reviewing records and data, Ashe County is a rural area, and simply has the student population that has more students with significant cognitive disabilities. We are barely over the 1.0%. This contributes to the alternate assessment participation rate. Ashe County Schools EC department went through a State monitoring for compliance this spring and there were no deficiencies in this area.
