Disproportionality will be addressed by tracking data on race, gender and socioeconomic status to ensure disproportionality (if present) is managed. Phoenix Academy will ensure that all processes are followed in a uniform manner regarding all students and IEP team decisions. Phoenix does not collect data regarding student socioeconomic status.

4. Phoenix Academy is a charter school that educates students from 7 surrounding school districts. It has a thriving and well-established EC program with 2 self-contained classrooms teaching Extended Content Standards. Phoenix Academy has the following number of students participating in EOG testing and NC Extend I.

Prior to test administration, test administrators are trained on how to administer NC Extend I. This training takes place approximately 1 week prior to test administration. Test administrators sign a certification that they have received training and understand how to administer the test.

Students are assessed on an ongoing basis throughout the year to determine continued eligibility of criteria to participate in NC Extend I. Data include work samples, progress monitoring of IEP goals, iStation and Dreambox progress, and formal testing data (psychoeducational evaluations).
