The Director of Testing provides direct training on the Testing Students with Disabilities manual annually and copies of the manual are distributed to each school. This effort is coordinated with the EC Director who reinforces the procedures outlined in the Testing Students with Disabilities manual in meetings with EC case managers. All new students referred for NCEXTEND 1 services will be reviewed by the Director of Testing and EC Director.

For our small district, where the tested population within a given subject is often fewer than 3 students, statistical measures of disproportionality only approach meaningful levels when considering the entire tested population. Given that, disproportionality will be defined by any subgroup of the above groups representing greater than 70% of the tested population.

• Plans for how disproportionality will be addressed:

Subgroup data will be reviewed annually by the Director of Testing and the EC Director. Any disproportionality, as defined above, will be investigated and records for each student within the offending group will be audited and reviewed with the case managers to verify accurate placement.

4. Enter additional justification of variables not covered but deemed essential to understanding why the district/charter school has a higher rate of alternate assessment participation.

It is expected that Transylvania County will exceed the 1.0 % threshold for the Grade 11 Science category during the 2017-2018 school year. After careful review, it has been determined that this overage is an anomaly created by the retention of a student within the tested group. The retention resulted in the addition of one student to the tested population within that group and, due to our small population, that was enough to exceed the 1.0%. As a district we are well below the 1.0% threshold and all of our students participating in the NCEXTEND 1 assessments are qualified based on the requirements delineated in the Testing Students with Disabilities manual.
