#### CHARTER APPLICATIONS

#### APPLY TO OPEN A CHARTER SCHOOL

This page provides information on requirements to submit a public charter school proposal to the North Carolina State Board of Education.

NOTE: This application is not to enroll your child into an individual charter school. If you are seeking enrollment at a charter school, please refer to the schools webpage for a list of contact information for all charter schools in North Carolina.

Applying to open and operate a public charter school is a multiple step process.

For schools to open in Fall 2016

Prequalification for Fast Track is due no later than April 1, 2015 Online submission https://schools.nc.gov/fasttrack

### What is the process for Fast Track?

- Determine if you are eligible from the requirements.
- Apply for NCID
- Complete the Prequalification before April 1, 2015
- Wait for approval to start application
- Complete the application by July 1,2015 at 5:00PM EST
- Interview in September when requested by CSAB
- See if you are approved in October (CSAB) and November (SBE)
- Open school in Fall 2016 forgoing the planning year as outlined in policy TCS-U-016

### How do I register for NCID?

- Once you have determined if you are eligible, you will need a NCID. That can be attained from this website: <a href="https://ncid.nc.gov/">https://ncid.nc.gov/</a> for completing the prequalification phase.
- Access to the application link: <a href="https://schools.nc.gov/fasttrack">https://schools.nc.gov/fasttrack</a> If you have problems: Contact the NCID Help Desk Phone 919-754-6000 or toll free at 1-800-722-3946
- The last step is to fill in all of the required fields of the application by July 1,2015 at 5:00 PM EST. Do not leave anything blank (i.e. N/A is an option) as outlined below.
- Follow the timeline to see if you are approved for opening in Fall 2016.

#### What are the Application Specifications?

#### Applicants MUST submit applications by July 1, 2015 at 5:00 pm EST deadline; applicants are to use the following specifications:

- All applications must be submitted using the online platform. Applications submitted outside of this
  platform will not be accepted.
- All submitted applications must be from an approved nonprofit group by the NC Secretary of State
- Each major section (Mission, Purposes and Goals, Education Plan, Governance and Capacity, Operations, and Financial Plan) must be located within the designated section, as indicated in the online document.
- If a particular question does not apply to your team or proposal, respond "Not Applicable," <u>AND</u> state the reason this question is not applicable to your team or proposal.
- All required Appendices should be clearly titled and include page numbers (i.e. Appendix A and page numbers as- A1, A2, and B1...).
- Review all elements of your application for completeness before submitting. An incomplete section <u>will</u>
  result in the elimination of the application.
- Late submissions will not be accepted. No exceptions.
- Applicants must turn in the application fee by the stipulated timeline.
- Complete application packages must be submitted through the online platform. ALL applications are due by 5:00 pm EST on July 1, 2015.

#### **FAQS**

- Fast Track requires specific guidelines found in the eligibility requirements and are intended for replication of High Quality Charter Schools that <u>exceed</u> District and State expectations.
- A \$1,000 non-refundable application fee must be submitted for your application. You may submit up to 2 applications this cycle. Payments are to be made by: Mailing in Application Fee Payment Form with a Bank Issued Check or Money Order.
- If you do not qualify, the prequalification phase will not let you submit.
- Data for prequalification was checked through Accountability.
- If you are late on any timeline you will be disqualified. April 1 and July 1 are important deadlines that are required by policy.
- Fast Track is for the replication of a school and its board that is successfully exceeding expectations. Please feel free to apply for new schools charters in the regular application phase.
- Warning letter information can be found in State Board Policy TCS-U-oo6 –Impact of Financial, Governance, and Revocation
- Must have 3 years of preceding data to be eligible.
- Must adhere to the Dissolution plan in Appendix W where \$50,000 be placed aside solely for closure proceedings.
