New Funding Opportunity for Asbestos and Lead-Based Paint Activities – Upcoming Webinar for All PSUs

The NC DHHS Health Hazards Control Unit (HHCU) is providing a presentation regarding the American Rescue Plan Act (ARPA) Reimbursement Program for NC Public Schools and Charter Schools on **Wednesday, January 10th at 10:00 am**. Under the ARPA Reimbursement Program public schools can be reimbursed up to two-thirds for eligible expenses related to asbestos or lead-based paint abatement or remediation activities. Funding for reimbursement will be available until December 31, 2026, or until it is depleted, whichever comes first.

Legislated Survey for Federal Use of Funds – All PSUs

The Survey for Federal Use of Funds has opened and will close on **Friday, January 19, 2024, at 11:59 p.m.** This mandatory reporting, per <u>Session Law 2021-3 Section 1.8.</u>, requires all public school units (PSUs) to submit quarterly reports to the Department of Public Instruction on the use of specific COVID funds. The surveys sent are in accordance with this legislation and to facilitate the compilation of more than 300 submissions. We are collecting data for **PRCs 171 through 178**. The survey structure and questions remain the same as in the previous collection.

Do not include any other PRCs except those listed.

Do you have more than 20 positions to submit?

PSUs with 20+ positions should submit the "<u>Established Positions</u>" survey via **email** using the Excel spreadsheet attached to the communication sent today, Friday, January 5th, 2024 at 8am. **Only PSUs with more than 20 positions may use the Excel form.**

You must submit the survey "Expenditures and Use of Funds" online even if you are submitting the position details via email. Follow the file's instructions carefully (refer to the Excel file tab "instructions") – you must change the file name to indicate your PSU number and when sending the survey. Your email subject line must include the file name with your PSU number. Do not change or modify the design of the Excel file by inserting or deleting columns or changing the format, otherwise your submission may be delayed or not accepted. Restart Transfers - LEAs Only

The Restart module required system changes to reflect the appropriate LEA average salaries for PRC 004/Program Enhancement Teachers. All requesting Restart LEAs should review their submitted entries for correctness and resubmit if needed. If your transfers include PRC 004, you will need to assess any calculated differences, make the necessary transfer amount adjustments, and resubmit. If you have yet to enter your Restart transfer determinations please enter them as soon as possible, the deadline was extended until **Monday, January 22, 2024, 5:00pm**. Additionally, please ensure to click the "Apply Changes" and "Submit" buttons where applicable so that your transfer requests are submitted properly after final reviews.

Bonus Allotment Adjustments (PRC 048) - All PSUs

An adjustment allotment is being processed for PRC 048/Principal and Other Teacher Performance Bonuses. The previously allotted bonuses (Revision #27) lacked the FICA portion of the AP/IB/AICE bonus. PSUs should be able to see their additional funding to cover FICA early next week.

IRS Mileage Rates Increase

Effective January 1, 2024, the Internal Revenue Service (IRS) has established <u>new mileage rates</u> used to calculate the deductible costs of operating an automobile for business, charitable, medical or moving purposes. The business standard rate for the use of a car (also vans, pickups or panel trucks) increased from 65.5 cents per mile to 67 cents per mile. Accordingly, and pursuant to G.S. 138-6(a)(1), OSBM will adjust the allowable rate of reimbursement for travel by officers and employees on official state business.

In 2022, the Travel Policies and Regulations section (5.2.13) of the State Budget Manual was updated to reflect **that unless otherwise specified, OSBM will adopt new IRS mileage rates effective January 1 of each calendar year**. In accordance with an agency's policies, a state employee shall be reimbursed at a rate that does not exceed the business standard mileage rate set forth by the IRS. Agencies are advised to visit the IRS website to confirm the annual mileage reimbursement rates on or before January 1 of each year.

From the Office of Systems Modernization

NCDIT Public School Unit & Local Government Unit Subscription Cost Recovery Billing

This message is to inform you about recent changes to public school unit and local government bills for services provided by the N.C. Department of Information Technology. Beginning with Dec. 15, 2023, invoices, all local government and school system customers now pay a subscription fee, in addition to the service rate to ensure NCDIT recovers its costs as required by law. Subscription cost is the base charge to customers who use NCDIT as a service provider. This charge is to cover the customer's pro-rated share of NCDIT operating expenses.

The monthly subscription charge you are now seeing on your bill is for the 2023-2024 fiscal year and represents the annual total for this fiscal year divided by 7 months to account for the state budget being approved in October.

NCDIT calculated subscription charges for the 2023-2024 fiscal year for each customer based on their use of IT services (e.g. use of the CICS Mainframe "Region F" MSA Cash Management/Cash Request System) in FY 2022 and nine months of FY 2023.

After determining the average for each customer, NCDIT calculates each customer's percentage of the total. The percentage is then applied to the total subscription budget for the year to determine the amount an individual public school unit or local government is billed.

FY24 Federal Initial Allotment Summary (Various PRCs) - All PSUs

Improper Payment Review: IDEA & ESF - All PSUs

This year's U.S. Department of Education (USED) Improper Payment Review studies have started. North Carolina has been selected to participate in the IDEA and Education Stabilization Funds (ESF) studies. USED will be requesting NC DPI to collect documentation used to validate payments for a sample of transactions from various PSUs. Each sample item selected represents a cash draw down and the entire amount must be substantiated.

We expect to receive a list of the sample items for the reviews in February. PSUs selected will be notified of the date that they need to provide supporting documentation. Note there will be a tight timeline for this type of review. PSUs selected must submit a reconciliation of all payments and cash zero outs, if applicable, that make up the amount noted in the cash draw identified. We will publish the expected dates for both studies as soon as the dates are shared.

Reminders Concerning ESSER Funds Used for Construction - All PSUs

- Construction Projects require a Certificate of Review prior to beginning construction from <u>DPI School Planning</u> **Applicable to LEA's Only**. Please consider the lead time for the review by School Planning, which is currently 8 weeks.
- ESSER III (PRC 181) projects need to be scheduled with an intention to be complete by the end
 of the period of performance. The liquidation period expires on December 29, 2024. There will be
 an opportunity to request an extended liquidation; however, there is no guarantee that extensions
 will be available or granted.
- Construction work at schools using Federal Funds must comply with Federal regulations including Davis-Bacon wage requirements. For more information please see <u>the ESSER and GEER</u> FAQ and the information on <u>construction in the DPI Website</u>.
 - Davis-Bacon wages must be paid for any construction related work paid for with Federal Funds.
 - The Davis-Bacon requirement applies to construction, alteration, and or repair of public buildings including painting and decorating (29 CFR 5) over \$2,000.00.
 - Examples of types of work that required Davis-Bacon includes work over \$2,000 for services such as: mounting/installing security systems, installing keyless entry systems, removal of walls, installation of portable classrooms, repair of sidewalks, and similar work on school facilities.

Center for Safer Schools Awards \$35 Million in School Safety Grants

Two hundred thirty North Carolina school districts and charter schools will benefit from \$35 million in safety grants announced Jan. 24 by the Center for Safer Schools.

The funding will be used for safety equipment, training and services for students in crisis. Safety equipment covered by this grant includes items such as cameras, vape detectors, radios and weapons detection systems. Training can include professional development for school leaders to assist students who are experiencing anxiety, trauma and/or conduct problems. Services made available through this grant can include school-based mental health services.

CFSS Executive Director Karen W. Fairley said each application was thoroughly reviewed.

"It is part of the Center's mandate and mission to give public-school units the tools they need to help keep their schools safer – that includes grant funding," she said. "We thank the General Assembly for its generous appropriation that enables us to support North Carolina public schools." Funding for the hiring and training of school resource officers was a continuation of the \$33 million in SRO funding awarded in October 2022 for the 2022-23 school year.

Awards are subject to all administrative and financial requirements, including timely submission of all financial and programmatic reports; resolution of all interim audit findings; and adherence to allowable expenses.

FY24 Federal PRC Data in BAAS (Various PRCs) - All PSUs

At this time, the forward funded flags are set to be flipped once the Allotments Section has received the final approvals from the Federal Programs and EC areas. We expect to receive the final allocations within the next 2 weeks and will update you when these actions have been completed.

After that has occurred for a PRC, the system will look at the actual (Initial) allotment amounts. We apologize for the inconvenience caused by the unalignment of the systems., thank you for your patience as this is a safeguard for DPI's federal compliance requirements. You should work with your financial software vendor to ensure they have the appropriate functional work arounds so your business operations are not impacted.

ESSER II Close-Out - All PSUs

We have executed our preliminary reversions of the ESSER II grants and others that ended December 2023 at the end of January. DPI has a final reconciliation process that we will be doing in the next couple of weeks. We will provide instructions to you related to how and what supporting documentation you need to provide should your data differ from what we have executed in the next couple of weeks.

Keep in mind, the only allowable expenditures from October thru December for the ESSER II grants were for those funds and exact codes that had allowable encumbrances at the end of September. Any expenditures outside of those codes were not eligible for expenditure during that period.

Stop Arm Enhancement Grant Funding Application - All PSUs

In SL 2023-134 the NC General Assembly directed non-recurring funds for DPI to establish a grant for Public School Units (PSUs) to acquire and install Enhanced School Bus Stop Arms. The program has been established by NC DPI and is governed by State Board of Education policy ALOT-003 which indicates that it will be distributed via allotment in PRC 087.

Three options exist as outlined in the application linked below: extended stop arm, LED illuminated, or both extended and LED illuminated. The application linked below may be submitted by any PSU which has yellow school buses, as defined in <u>G.S. 20-4.01 (27) n</u>. The total amount of funds available for award by the Superintendent of Public Instruction to all recipients is \$370,758. The application related to this grant opportunity was provided to Transportation Directors, the Office of Charter Schools, and others receiving NC DPI School Bus list emails on Friday January 26th.

Charter School Average Daily Membership (CSADM) - IPSs Only

Phase I - Submission for FY 2024-2025 ADM Projection due by February 18, 2024

The new legislation removes the cap on the maximum allowable ADM growth for schools that do not have a low performing status. This adds a significant challenge to DPI being able to project charter school growth and ensure sufficient funding from the General Assembly. School Business must rely on the charter schools, and it is CRITICAL that School Business Services receives the most accurate planned ADM for the 2024-25 school year. This information will be the basis for our budget request from the General Assembly and will ensure that we have sufficient funding to fund each school's growth.

We have updated the system to capture critical data related to these projections and to meet the new legislation. The system will step you through the process.

All Charter, Regional, and UNC Lab Schools with current year enrollment and new charter schools approved by the State Board of Education to open July 1, 2024 are required to report.

All charter school's Head of School are required to submit between February 8, 2024 – February 18, 2024 the CSADM Phase I – Submission for FY 2024-2025 ADM Projection.

Updates to the Allotment Policy Manual

The following changes were approved by the NC State Board of Education during their monthly meeting on March 7, 2024. The adjustments have been made in the allotment policy manuals posted to ou<u>r allotments webpage</u>.

Digital Learning Initiative (DLI): Digital Literacy Solution (PRC 078)

The deadline to expend funds for licenses was extended from January 31, 2024 to March 31, 2024 to allow school districts time to obtain approval from their local boards.

Health Career Promotion (PRC 253)

This policy was amended to note that it is funded with ARPA Temporary Savings Funds that do not revert. The Department will not disburse any funds until the State Budget Director has notified the Department that the funds will be remitted, and a special provision in line with law was added, which allows DPI to 5 percent of those funds for the direct costs for the statewide administration of the program.

Plasma Games Grant Program (PRC 258)

Revisions included a note that this program is funded with ARPA Temporary Savings Funds that do not revert. The Department will not disburse any funds until the State Budget Director has notified the Department that the funds will be remitted. The policy was updated to add a special provision in line with law which allows DPI to 5 percent of those funds for the direct costs for the statewide administration of the program. The funding formula was also modified to address allotments if the total of all approved applications for funding exceeds the total available funding.

ARP - ESSER III - Summer Career Acceleratory Programs (PRC 188)

The funding formula was modified to allot remaining funds to the NC District Summer Learning Network participating districts.

ARP - ESSER III - Supplemental Academic Enrichment Programs (PRC 189)

The program purpose was expanded to cover supplemental enrichment activities in K-12th grade; the previous policy only covered grades 4-8.

Updates to the Allotment Policy Manual

The following changes were approved by the NC State Board of Education during their monthly meeting on April 4, 2024. The adjustments have been made in the allotment policy manuals posted to our <u>allotments</u> <u>webpage</u>.

21st Century Community Learning Centers (PRC 110)

Amended to increase the maximum allowed allotment from \$400,000 to \$500,000. Special provisions were added to outline attendance guidelines and how funding will be distributed in three installments. Funds recovered from reduced enrollment can be redistributed to other grant recipients. Summer program funds will be sent in one installment after April 1 each year.

School Improvement Funds (PRC 115)

In the current model, federal school improvement funding supports Comprehensive Support and Improvement Schools and Innovative Partnership Grant Schools. The amendment broadens the flexibility within the policy to allow funding support for Targeted Support and Improvement Schools.

Middle School Reading (PRC 257)

Updates the funding formula from \$250 per ADM to \$201.80 per ADM to align with the Best 1 of 2 average daily membership report.

New Guidance from USED on Notice of Federal Interest for ESSER Funded Construction or Real Property Projects - All PSUs

On March 21, 2024, the U.S. Department of Education (USED) issued new guidance on ESSER funded renovations, major remodeling, construction, or other real property projects. (<u>USED Recording and Reporting Federal Interest</u>)

Per the new guidance, all grantees and subgrantees that have a renovation, major remodeling, construction, or real property project (Project) using \$1 million or more in Federal funds **must** record the notice of Federal Interest (NFI) by **January 28, 2025**.

Projects which cost less than \$1 million are generally exempt unless situations or circumstances exist which may require recording of the NFI as a "prudent safeguard to further protect the Federal interest from other liens that could prevent the building from being used for its educational purposes." Examples given in the new USED guidance:

- · Project may require recording NFI if the Federal funds represent a vast majority of the total value
- Project may require recording NFI if the Public School Unit (PSU) or LEA is in high-risk status.

For additional guidance, please review the updated <u>Frequently Asked Fiscal Questions Related to ESSER</u> and GEER, Includes Construction Related Questions section on construction and related questions.

Please note: This exemption **does not apply to other construction or annual real property reporting**. All grantees and subgrantees are still subject to annual reporting on the status of construction or real property projects.

From the Office of Federal Programs - All PSUs ESSER Prepayment

North Carolina has revisited its stance on allowing pre-payment of subscriptions and software licenses. Based on the latest presentations from Bruman and the current wording of ESSER FAQ guidance, prepayment of subscriptions and software licensing will be allowed with ESSER III funds. Prepayment can extend through the 2025-26 school year, not extending beyond June 30, 2026.

Prepayment is different from a liquidation extension.

- Prepayment requires that the subscription or software license be obligated by September 30, 2024 and paid in full prior to the end of the liquidation period.
- Liquidation Extension a request to extend the time beyond the liquidation period due to circumstances that prevent the project from being completed. This is intended for impacts due to unforeseen circumstances or delays and market impacts.

It is important to note that prepayment flexibility is only extended for ESSER III funds. If you have any questions regarding prepayment, please contact your regional federal program administrator. Additional guidance will be provided in the <u>Frequently Asked Fiscal Questions Related to ESSER and GEER</u>, Includes Construction Related Questions.

DPI is in the final stages of reconciliation work for the closed ESSER II PRCs. If funding/cash adjustments are needed, we will execute those transactions and then provide you with an email that includes information for your bank reconciliations. As we near year end:

- 1. Begin to move over-reported expenditures out of the closed ESSER II PRCs grant PRCs.
- 2. Cash for these ESSER II PRCs is no longer available for request. Do not request cash for the closed PRCs unless you have been approved for an extended liquidation.
- 3. Cash provided in excess of expenditures should be refunded back to NC DPI.

Continued activity in these closed PRCs creates possible compliance issues. We anticipate completion of the reconciliation in the upcoming weeks. Thank you for your patience during this process. ESSER Prepayment Reminder from April 5th Newsletter - All PSUs

North Carolina has revisited its stance on allowing pre-payment of subscriptions and software licenses. Based on the latest presentations from Bruman and the current wording of ESSER FAQ guidance, prepayment of subscriptions and software licensing will be allowed with ESSER III funds. Prepayment can extend through the 2025-26 school year, not extending beyond June 30, 2026.

Prepayment is different from a liquidation extension.

- Prepayment requires that the subscription or software license be obligated by September 30, 2024 and paid in full prior to the end of the liquidation period.
- Liquidation Extension a request to extend the time beyond the liquidation period due to circumstances that prevent the project from being completed. This is intended for impacts due to unforeseen circumstances or delays and market impacts.

It is important to note that prepayment flexibility is only extended for ESSER III funds. If you have any questions regarding prepayment, please contact your regional federal program administrator. Additional guidance will be provided in the Frequently Asked Fiscal Questions Related to ESSER and GEER, Includes Construction Related Questions.

From the Office of School Nutrition

USDA Supply Chain Assistance Funds Allotment (4th Round) - all PSUs

Office of School Nutrition has allocated the 4th round of SCA (Supply Chain Assistance) Funds this week. Eligible and approved School Food Authorities (SFA) can see their amounts in the School Nutrition Technology System (SNTS), under the School Year 2023-2024, in SNP > Claims > Claim - FUNDS for SNP.

Note that this is the same SNTS location that you can look up your prior SCA allocation (under appropriate school year). Unlike prior rounds, the 4th allocation of SCA funds were made available to SFA without having to go through the claiming process. NC DPI have deposited the funds to SFA bank account or sent a paper check (depending if your SFA is set up for ACH). The batch payment was processed at NC DPI on 4/25/2024.

The Q&A document on SCA Funds is available under <u>SN News & Events page</u>. As a reminder – if you are receiving SCA funds, you are required to submit quarterly reports to the Office of School Nutrition on the use of these funds. This requirement is in effect until the funds have been used. If you need the Qualtrics survey link, contact your school nutrition consultant.

071 funding is applied correctly in the field. Should they not be working directly with students, those should be considered central office positions and should be coded to location 810.

For FY 23-24 and thru Sept 30th, 2024, the funding is in PRC 198 and is funded from ESSER sources. There was an additional \$1 million added of ESSER funds added to support the program this spring. Please use PRC 198 for all reimbursements for the funding appropriated. These funds expire on September 30, 2024.

For FY 24-25 and moving forward the State has provided \$1million recurring State funding for this effort and codified the program into law (<u>SL 2023-134, Section 7.40</u>). These funds will be allocated beginning in November in STATE PRC 255. That COA and Allotment Policy will be made available in FY 24-25 prior to the allocation of the funding.

The Office of Licensure and Education Preparation (OLEP) prepared the allotment for the ESSER Funding using the two methodologies allowed under the program and to transition their application and model to the

new upcoming State funding process. That is the reason behind the separation of the funding notifications since there are two distinct groups receiving the funding. Please follow the appropriate program requirements under those two models. The OLEP can assist your HR and Payroll Staff's if additional information is needed.

Update: FY 2024-2025 Budget - All PSUs

The House and Senate agreed to authorize the salary increases that were "intended" for the second year of the biennium. This action took place in <u>Senate Bill 332</u> and is awaiting the Governor's signature before it becomes law. These increases impact all public school employees.

The 2024-25 salary schedules are posted on our <u>What's New page</u> and the noncertified increase is 3%. The benefit rates would be those as presented in the biennium budget for FY 2024-25 [<u>SL2023-134</u>, <u>section 39.26 (c, e)</u>]:

Retirement Rate: 24.04%Hospitalization rate: \$8,095

SB332 also has a special provision modification to the PRC 071 supplant language that impacts only 3 LEAs and those LEAs are aware.

No additional budget action is anticipated in the near term and in the event that SB 332 is signed into law, School Business staff will begin our process to execute the State Initial Allotments with the second year items. Information will be sent out next week with the timelines of budget implementation items that impact LEAs, Charter Schools, and Lab schools, including ABC transfers, NCVPS reductions, restart transfers, and IFE conversions.

Federal balances by Grant Year from June 30th will be allocated as soon as we complete the close-out process and complete calculations. Our target date is no later than July 11th. Reminder: the balances through May expenditure data are posted on our What's New page.

Invalid Account Codes (Monitoring Reports) - All PSUs

There are still many Public School Units (PSUs) who are reporting invalid account codes in their monthly financial data. Review your latest May 2024 Monitoring Reports that list your invalid account codes.

All expenditures must be coded to valid account codes. The PSU must reclassify any invalid account codes prior to the fiscal year end close out. Failure to correct invalid account code postings may result in incorrect data file postings and the pulling back of state and federal funds during the year end zero out process. The results will be that your PSU will lose their ability to receive the cash for the expenditures coded to invalid account codes.

Please see the <u>attached document</u> which summarizes the new COA that went into effect July 1, 2024. It has been posted to our <u>What's New page</u> as well. Your vendors should have your software set up accordingly. Please be aware especially of the Fund 3 - Federal Grant Year requirements. Below is an excerpt from the attached document:

The new COA also helps establish the Grant Year funding code segment required by the State to ensure appropriate grant year reporting for the federal funds with the new State ERP Accounting System (NCFS).

- Grant Year reporting is required for all FUND 3 (Federal Grants). The X for the grant year segment in Fund 3 must carry a valid # (0 through 9) to align the expenditures to the grant year allotment and cash being drawn from USED for those grants.
- Should a value of 3X be received in the monthly UERS Data File transmissions, that will be treated
 as an invalid account code and may result in the pullback of federal funds when the monthly
 processing for cash zero-out is completed.

Other non-defined new segments will return either the X or a Zero, until they are defined by either the LEA (Y) or DPI (X).

FY2024-25 State Initial Allotments - LEAs

The Legislative Increase (LI) adjustment to base salaries will be processed today in revision #013.

The benefit adjustments of 24.04% for retirement and \$8,095 for hospitalization were already included in the preliminary initial allotment received to-date.

For consistency, the PRC 054 Limited English Proficiency (LEP) LI adjustment that was previously processed in revision #010 was reversed and will be reallotted in revision #013 as well. This technical adjustment will have a net zero impact on your LEP allotment.

FY2024-25 State Initial Allotments - IPSs

Independent Public Schools (IPSs) will receive a budget adjustment for the per pupil share of the Legislated Salary Increase (LI) allotted in PRC 036 for Charters and PRC 038 for Lab Schools. This budget adjustment is \$111.47 per ADM and represents all adjustments to all initial allotments. Note that the LI associated with Exceptional Children's (EC) and Limited English Proficient (LEP) funds are allotted separately. The LI associated with the EC funds was included in the EC allotment in revision 006. The LI associated with LEP funds will be distributed in revision #013.

Additional Allotment Updates- All PSUs

A budget adjustment was completed in revision 010 to adjust the Low Wealth Supplemental Funds (PRC031) to reflect the full formula funding.

All PSUs located in a low wealth county received their respective portion of that funding in that revision.

Several allotments that are related to restricted allocations or grants will be distributed next week along with the "kitchen sink" allocations, which includes various allocations that are not included in initial allotments.

We will provide further updates after those distributions are completed. Thank you for your patience as we execute the FY24-25 budget.

August State Board Meeting Update

The NC State Board of Education (SBE) approved the changes to the Manuals below during its monthly meeting on August 1, 2024. The adjustments have been made in each manual and posted to <u>our What's New webpage</u>.

Allotment Policy Manual

The updates below will reflect new legislation and SBE policy changes, as well the new leading zero PRC coding for the expanded Chart of Accounts and systems modernization efforts. Following is a summary of the changes:

Federal Allotment Policy:

 PRC 082 IDEA Special Education State Improvement Grant - Removes language to ensure funds do not revert but are available for the full 60-month period. It is a competitive grant.

- PRC 085 Literacy Interventions Clarifies language for the next phase of the Science of Reading work.

- PRC 071 Supplemental Funds for Teacher Compensation 2024-25 language for the supplanting calculation and provides a remedy option for 2024-25. Provides the requirements to remedy any deficiency to be eligible to receive an allotment in FY 2024-25.

NC Public School Personnel Salary Schedules and Manual

Updates were made to implement the 2nd year of the biennium, including Salary Schedules for Public School Employees (Session Law 2023-134, SL 2024-39, and other legislation). This includes a change to the Superintendent's Schedule to align with legislation and allow the LEAs to determine the ADM ranges associated with the legislative salary levels.

School Attendance and Student Accounting (SASA) Manual

The SASA Manual was amended to implement pertinent legislation, funding in arrears, and the new Student Information System (SIS). Revisions include the admission of out-of-state and foreign exchange

students to charter schools, withdrawing students from school, coding attendance on individual student make-up days, the class size waiver request process, guidance about eligibility for use of a modified school calendar, retention of digitized student records, and assignment of Student User Identification numbers. Information about the addition of Pre-K ADM to the K–13 ADM for purposes of school principal salary calculation was added as well; changes to the Principal Salary Schedule are effective January 2025 and will be brought before the Board in the fall for final approval.

Reminder About Inclement Weather Closures

School Closings and Instructional Time

Be sure to follow your PSU's Inclement Weather policies in addition to these reminders.

If school is closed in advance of inclement weather (school closed the day before), follow your PSU's plan for making up missed days.

If school is closed early due to inclement weather, the day and the scheduled amount of instructional hours count toward the required minimum number of days and instructional hours.

If school buses are in route to schools when school is canceled for the day, then the day and instructional hours scheduled for that day will count toward the required minimum.

December Pay Date

Some LEAs have received a copy of an internal DPI communication that stated that the Office of State Controllers will no longer process the December pay before the holidays and will move the pay date to December 31st. Several finance officers have asked School Business Services if this applies to the LEAs.

This communication does not apply to LEAs as the local boards have flexibility in setting their pay dates. However the LEA pay dates must be in compliance with General Statutes. The following are the laws as they apply to LEA pay dates:

Teachers: Although teachers are required to receive a full monthly payment no later than August 31st, and this constitutes prepayment for teachers working on a traditional calendar, the LEA is not permitted to extend the pay intervals more than one month. Therefore, if the LEA pays a teacher before the end of December, the LEA may not extend the next payment to the end of January. Teachers are required to receive their pay in monthly installments. (reference <u>G.S.115C-302.1</u>)

Superintendents, supervisors and principals shall only be paid for the days employed as of a set pay date and may not be prepaid for days not employed. (reference <u>G.S. 115C-272(b)</u>, <u>115C-285</u>)

Other employees: Each LEA shall establish a set date on which monthly salary payments to employees other than superintendents, supervisors, and classified principals employed on an annual basis, shall be made. This set pay date may differ from the end of the calendar month of service. Employees may be prepaid on the monthly pay date for days not yet worked (Reference <u>G.S. 115C-316</u>)

CCIP eGrants Management: "No Carryover" & "Budget Only Remaining Funds" - All PSUs

Starting this year, there will be "no carryover" due to the implementation of the Grant Year Accounting fresh start. You will no longer see funds listed under the "Carryover" column. Any remaining carryover funds have been reallocated to the Grant Year (GY)-budget system or Fiscal Year (FY)-CCIP system, in which the funds were originally allotted. These funds must now be budgeted and expended from the corresponding

grant/fiscal year.

Planning allotments for the current year have been assigned to the FY-25 PRC application shells and GY-X5 within the budget building platforms. For any years prior to GY-X5 / FY-25, the term "Budget Only Remaining Funds" will appear in the grant title. This reflects any funds left over from that year as a new allotment, which would have previously been categorized as carryover.

To clarify, carryover funds remain within the GY/FY in which they are allocated, creating up to three budgets per PRC. For example, "Carryover" from GY-X4 / FY-24 will no longer appear in GY-X5 / FY-25. Instead, these funds will be found under GY-X4 / FY-24 "Budget Only Remaining Funds," where they were initially allotted.

Should we need to collect the previous years of data, we will send out a follow-up survey. We will send out an additional survey for 2024-25 in the spring.

NCDPI will compile the data into a report to submit to the State Board and the JLEOC. Following your response to these surveys, there is no further action required from your PSU.

Required Postings on LEA Websites - LEAs Only

The ABC Transfer Budget Flexibility Report is required to be posted on LEA's websites per G.S.105.25. (c) by **October 15th** and posted for a minimum 3 years. LEAs are also required to provide the details below for all transfers which increased or decreased the allotment amount by more than 5%:

- The amount of the transfer.
- The allotment category into which the funds were transferred.
- The purpose code for the funds following the transfer.
- A description of any teacher positions fully or partially funded as a result of the transfer, including all subject areas taught by the teacher in that position.
- The educational priorities that necessitated the transfer.

All LEA finance officers should have received an Excel template with the 2023-24 ABC transfers that met the threshold. The template was sent via email to the finance officer identified in EDDIE on Wednesday, September 12, 2024. That email also included PDF file "ABC Transfers Guidelines FY2024" that will help with completing the excel template. The PDF has been posted to the What's New webpage.

If a district does not have any transfers that increased or decreased the allotment amount by more than five percent, NC DPI believes the district is not required by the legislation to post anything. However, for clarity and transparency purposes, these districts may opt to state on their website they have nothing to report for that particular year.

In addition to posting the information on the LEA website, all LEAs are required to complete the template and submit to Michael Ray at the email below by **10/15/2024**, so that School Business can comply with legislated requirements. Reminder: Federal Grants Ending on or Before Sept 30, 2024

Please be reminded that there are several federal grants that are now allocated and must be accounted for by grant year whose period of performance ends on or before September 30, 2024. The <u>list of grants</u> has also been posted to our <u>What's New page</u>. ESSER related funds must be encumbered (committed) by September 30, 2024 (contract/purchase order issued/recorded in the system); cash must be expended no later than December 30, 2024. After September 30, no ESSER related funds will be available for encumbering, and after December 30, 2024, funds that had been encumbered will not be available for payment.

Please review your federal allotments to ensure you have expended those funds before those grants end. This includes ensuring you have recorded all expenditures and if needed eligible encumbrances to the appropriate grant year in your system. Reminder grant year reporting means that expenditures and cash drawn are all accounted by grant year for the federal grant funds. These must align. Please work with your software vendors if you are still unclear how to appropriately account for these funds using the new grant year code segment in the Chart of Accounts (COA).

Federal Grants - Fiscal Obligations, Liquidations and Reversions FAQ

Guidance for Federal Reversions has been updated to ensure compliance with Federal requirements and ensure efficient processing is in place. A Federal Grants - Fiscal Obligations, Liquidations and Reversions FAQ can be found on the What's New page. As a reminder:

- Encumbrances in object code 312 are allowable, except for participant travel costs, which would not be an allowable encumbrance under the Federal regulations. The PSU is responsible for complying with the allowable obligations.
- Indirect costs, that correspond to expenses encumbered, will also need to be encumbered.
- Only eligible obligations may be encumbered, payroll expenses and travel are not eligible and that
 other object codes may be excluded from allowable encumbrances based on the definition of an
 obligation outlined in U.S. Department of Education requirements in 34 C.F.R. 76.707.

- During the liquidation period, if any expenditures are reported to NC DPI outside of the specific
 account codes that were used to set up encumbrances reported at the end of the period of
 performance they will be flagged as unallowable costs and those funds will be pulled in the final
 reversion process.
- The account code related to the encumbrance cannot be changed during the liquidation period.

Upcoming Legislative Reports

We are approaching the time of year when multiple legislated reports are due to the NC General Assembly. If we do not have access to the necessary data, we must collect it via survey. In the future we hope to consolidate them during the long session, but in the meantime we appreciate your patience and prompt response to our data requests.

Voluntary Shared Leave Reporting 2023-2024 - LEAs only

(Excludes Independent Public Schools: Charter Schools, Lab Schools, and Regional Schools) This survey is collected annually in response to General Statute 126-8.3(c) and is due **September 30**, **2024**. The survey must be submitted online using the link posted on the What's New page. A preview of the questions, to assist with completing the online survey, is also available.

Charter School Membership Survey and Local Per Pupil Template – LEAs Only

The 2024-2025 survey and template are posted on the FBS homepage under <u>What's New</u> and are due by **October 14, 2024**. This survey is traditionally published annually in October. There are no changes to the survey from the previous year.

G.S. 115C-218-105(d) requires each LEA to provide to the State Board of Education detailed information related to the calculation and transfer of the per pupil share of the LEA's local current expense fund. LEAs are required to provide this information to the State Board of Education by November 1st of each year. In addition, School Business collects data annually on the number of students in each LEA attending charter schools.

All LEAs (not Charter, Regional, or Lab Schools) are required to submit data using both the survey and associated template (Excel workbook). Tip: Complete the template first, then open the survey. There is a place in the survey to upload the template. If you have questions, contact shannon.miller@dpi.nc.gov.

Small County/Low Wealth Signing Bonus for Teachers (PRC 0062) Survey - LEAs Only

If you are an LEA that receives Small County (PRC 019) and/or Low-Wealth funding (PRC 031) you may be entitled to additional funds appropriated in <u>G.S. §115C-302.8</u>. To prepare the allotment we require all eligible LEAs to complete <u>a Qualtrics survey</u>. The survey will ask your intent to participate in this program and the other pertinent information we need to prepare your allocations. This program does require matching local funds.

Please complete this survey even if you do not intend to participate in this program. If you have any questions related to filling out this survey, please contact Sue Holly at susan.holly@dpi.nc.gov. This survey will close on **October 15, 2024**, after which we will prepare the allotments based on the applications and within the budgeted funds provided.

Required Annual Reporting Due October 31, 2024

SS300 Local Salary Supplements Report – LEAs only

The SS300 Local Salary Supplements Report is completed by LEAs only. We have added an FAQ tab to answer questions about what is to be included in the SS300 report.

Restart Transfers - LEAs Only

The deadline has passed to enter FY25 Restart School Transfers into the Allotment System. We will extend the module until midnight, **September 20, 2024** for completions of your school's Restart Transfers.

Please go into the Allotment System, Restart_School_Transfer tab, Enter Transfer tab, 2. Enter transfers. Please note that if the transfers are not completed by 9/20/24 at midnight, Allotments will transfer the funds from PRC 003 Non Instructional Support and PRC 024 Disadvantaged Student Supplemental Funding to fund the needed dollars in Restart Schools.

Reminder About Inclement Weather Closures

School Closings and Instructional Time

Be sure to follow your PSU's Inclement Weather policies in addition to these reminders.

If school is closed in advance of inclement weather (school closed the day before), follow your PSU's plan for making up missed days.

If school is closed early due to inclement weather, the day and the scheduled amount of instructional hours count toward the required minimum number of days and instructional hours.

If school buses are in route to schools when school is canceled for the day, then the day and instructional hours scheduled for that day will count toward the required minimum.

Staff and Teacher Leave

PSUs may not forgive time not worked by staff due to inclement weather. If school is closed to both employees and students, a teacher shall work on the scheduled make up days. If students are not required to attend school during inclement weather but employees are required to report for a workday, a teacher may take an annual vacation day or make up the day by the end of the fiscal year. From the Office of Federal Programs

Pre-payment and ESSER Funds

In making a determination on the use of ESSER Funds to pre-pay services, please find the Frequently Asked Questions document issued by USDE on allowable uses of federal ESSER and GEER funding provided under the Coronavirus Aid, Relief, and Economic Security (CARES) Act and the Coronavirus Response and Relief Supplemental Appropriations (CRRSA) Act, and federal ESSER funding provided under the American Rescue Plan (ARP) Act.

See question E-3.d. "How long may ESSER or GEER-funded activities continue after the liquidation period?"

Generally, it is not good stewardship of Federal funds or prudent business practice to prepay for services that will extend many years into the future. However, under limited circumstances where a grantee or subgrantee timely obligates ESSER or GEER funds, ESSER- or GEER-funded activities may continue for a reasonable time beyond the liquidation period (including an approved late liquidation period).

Factors impacting how long ESSER- or GEER-funded activities may extend past the liquidation period include:

- Whether the funds were properly obligated and liquidated in a timely manner;
- Whether the activities would be allowed to extend beyond the liquidation period under applicable State and local procurement rules (i.e., a State or LEA must follow the same policies and procedures it uses for procurements from its non-Federal funds) (see <u>2 CFR §§</u> <u>200.317</u> through <u>200.327</u>, <u>200.403(c)</u>);
- Whether the extended activities constitute a reasonable and necessary use of Federal funds; and
- Whether prudent business practices (2 CFR § 200.404(b) & (d)) and internal controls (which
 generally limit prepayment) would support the continued activities for the length of time proposed.

Grantees and subgrantees must obligate funds by each program's deadline, which means that if a grantee or subgrantee enters into a contract for activities that continue past the date of obligation and the contractor does not provide the services, the grantee or subgrantee may not enter into a new contract or obligate those funds for a different allowable use. Instead, those funds that were obligated for services that were not delivered will remain unused and will be returned to the U.S. Treasury.

Because ESSER and GEER are State-administered programs, the SEA or Governor determines whether activities extending past the liquidation period are allowable under the circumstances. For example, an SEA may determine that it is reasonable and necessary under <u>2 CFR §§ 200.403-200.404</u> for an LEA to enter into a multi-year software licensing contract with a vendor during the period of availability of ARP ESSER funds and to pay for the entirety of the software license within the liquidation period. However, under the contract, the vendor would continue to provide the services (i.e., software and technical support) for some time after the funds had been liquidated.

Please be advised that the period of performance for this Program ends December 31, 2024. A normal federal liquidation period will follow. The end date of September 30, 2024 in the Allotment Policy Manual will be updated to reflect this accordingly at the November SBE meeting.

Please obligate your funds by the end of December 2024.

Zero Out Update - All PSUs

The decision was made to post the bank transactions for the zero out entries by the end of next week to avoid posting close to the September end of month payroll. The August cash zero out process will be based on year-to-date cash and year-to-date expenditures.

Sales Tax Refund - LEAs Only

For sales tax refunds on closed PRCs, please submit a check and payment memo to DPI.

Until an automated refund process is developed, PSUs can follow the steps listed below for sales tax refunds on open PRCs:

- Local refund sales tax amount to move to Core account
 - o Do not send a physical check unless it is a closed PRC (October for ESSER, etc.)
- Create negative cash request in the PSU Cash Application (PCA) for the amount of sales tax reimbursement
 - This will be the net amount of expenditures + sales tax combined
 - Example: expenditure amount \$100,000.00 * sales tax amount of \$1,000.00 = \$99,000.00 PCA cash request
 - Due to current system limitations in the PSU Cash Application (PCA), PSUs can only return up to the amount that they have requested
 - Example: YTD cash request in PRC181 is \$1,000.00. Sales tax is \$1,100.00. The entry can only be up to (\$1,000.00).
- Create contra account using sales tax account 04720 (previously object code 472 in COA) in budget

However, it may be best for the zero out to adjust cash due to the timing of the 9/30 deadline because the next cash request FRD date will be in October and after the grant expires.

Hurricane Helene Response and Recovery

Our thoughts are with you, your families, and communities devastated by Hurricane Helene, and SBS is committed to assisting you during this time. SBS has posted a guidance document, as well as other resources, to our What's New page. Non-impacted LEAs should be sure to look at the section on enrolling displaced students. The document has been updated today with guidance on the PMR. We will continue to update our documents and website as necessary during the coming weeks. New items posted this week include information from the Office of the State Treasurer, the Office of State Budget and Management, the Department of Insurance, and the Department of Employment Security.

In the meantime, if your PSU is located in a federally-declared disaster area:

- Absence Code: Please use absence code 55 to track staff absences. The guidance document provides information on how to get that set-up in your software.
- Cash: We have processed state Cash based on Total MTD September requests and that will be
 deposited to the state account on Friday. You will be able to adjust, or we can help with that later
 in the month.
- Datafiles: SBS, DPI IT, MCNC, and the software vendors are working to get financial systems operational. Finance Officers in 71 percent of impacted LEAs and Charter School Directors and Finance Directors in 96 percent of impacted IPS have successfully transmitted their September datafiles. SBS is working with the other PSUs without connectivity to stand up their fiscal operations and will continue to work with them on their data.
- Any impacted PSUs can contact SBS and Jennifer Bennett (<u>jennifer.bennett@dpi.nc.gov</u>) for any assistance needed.

We've provided some additional updates in the newsletter below.

PMR Submission Due Today

The first PMR is due today, October 4, 2024 for all PSUs.

If you haven't submitted your PMR yet because of outages related to Helene and your PSU is in a <u>declared Helene disaster area</u>, please don't panic. We are working with IT to develop a plan for next steps. Please note that both PowerSchool and Infinite Campus are cloud-based. Each system will work on any computer or phone with internet access. FEMA is hosting a series of webinars to cover procurement requirements. SBS will be coordinating webinars with the Governor's Office and FEMA next week. We will send out that information as soon as it becomes available.

October State Board Meeting Update

State Superintendent's Report

Superintendent Truitt presented <u>her legislative requests</u> for Hurricane Helene, based on what was provided for Hurricane Florence in 2018. She requested a hold harmless for staff missed days including school nutrition, as well as calendar and remote instruction flexibility, principal bonuses, and funding for building, equipment and technology loss. The General Assembly will reconvene on October 9th. SBS has been tasked with taking class size waivers to the Superintendent for approval.

NC Public School Employees Benefit and Employment Policies Manual

Updates were made to the manual to comply with Office of State Human Resources rules. The changes made clarified language about the charter school opt-in guidelines and length of paid leave offered to parents. The manual includes a new policy in the case of miscarriages, still births, or other medical exigencies.





Helene Relief Legislation

This week, the NC General Assembly introduced a Hurricane Helene and Potential Tropical Cyclone 8 (PTC8) relief bill, which was signed today by the governor (<u>Session Law 2024-51</u>). Prior Year LicSal Corrections

- To correct prior year salary audit exceptions, please email <u>Salary@dpi.nc.gov</u> and a Salary Analyst will help you by manually correcting them. For prior year refunds that require a manual check to be submitted, the LEA must submit them and complete the online form so that the correction can be made by Salary. Additional details will be forth coming regarding the online form.
- Given the manual nature of correcting prior year salary audits, the traditional deadline of October 31st has been extended through December. Those in the HELENE-affected areas will have longer to make those corrections, and Salary will work with them individually.

Current Year LicSal Corrections

- The System Modernization team is still updating the new LICSAL system to process the current year's salary information. July (PP1) and August (PP2) have been loaded into the LICSAL system. Reports are still being validated and updated. Once September (PP3) is loaded, salary audit exceptions should be more concrete.

Helene Updates

Yesterday, the NC General Assembly ratified a second Hurricane Helene relief bill (<u>Senate Bill 743</u>) impacting PSUs located in declared disaster counties. This bill is currently awaiting the Governor's signature. It includes:

- The opportunity to request additional calendar flexibility from the State Superintendent
- \$5 million for increased mental health support for students at affected PSUs
- \$50 million for facility repair and renovation costs not covered by FEMA or insurance
- \$5 million each for both technology in particular student and staff devices
- \$5 million school nutrition equipment replacement
 - This is in addition to the \$16 million to compensate school nutrition personnel for instructised days that will be waived, as enacted in SL2024-51
- The bill also includes a provision to waive the reapplication of students withdrawn fataffected schools for the 2025-26 academic year.

When the bill becomes law, we will recommend to the State Board of Education a modification to the allotment policy manual to authorize disbursement of the funds. School Business Services will provide supporting information to assist the PSUs related to these funds.

School Nutrition Inventory Losses for PSUs Affected by Helene

Please be aware that School Nutrition related inventory losses incurred because of Hurricane Helene will should be included in the PSU's insurance claims and/or FEMA claims. The state funds provided in the Disaster Recovery Act of 2024 (SL2024-51) are for salary and benefits ONLY for lost Instructional Days.

Note: These State funds do not apply toward compensation for any work related to clean-up, etc. as state funding cannot be used to compensate employees for the same hours twice. The Local BOEs have to

determine how best to compensate employees for HELENE related activities and how those may need to be documented to claim reimbursement from FEMA/Insurance for those costs.

It will be important for the School Nutrition Administrator and Finance Officer (or designee) to collaborate to ensure that all losses incurred by School Nutrition have been properly accounted for and supporting documentation for anticipated reimbursement is maintained and readily available upon request by FEMA.

As additional information becomes available, it will be shared through the Hurricane Helene "What's New" section of the Financial and Business Services website. SBS continually updates the FAQ and will have a section specifically for School Nutrition related questions.

ESSER III – Application for Liquidation Extension

The US Department of Education is providing a process to apply for an extension on the liquidation period for ESSER III funds. The US Department of Education acknowledges that some grantees may require flexibility liquidating remaining ESSER III funds. And is authorized to approve an extension on the liquidation period for properly obligated funds.

Public School Units (PSUs) may request an extension for ESSER III funds, as long as the funds were properly obligated by September 30, 2024.

The Final approval will be granted by the U.S. Department of Education, and is based upon the specific facts and circumstances, in accordance with 2 CFR § 200.344(b). If approved under this process, the liquidation period may be extended up to 14 months beyond the 90 days already provided to liquidate ESSER III funds.

Without an approved extension, obligated ESSER III funds must be liquidated by December 29, 2024.

Please note: this application is for ESSER III PRCs only, and does NOT include the ARPA Homeless Youth (PRC 182 and 183) or ARPA IDEA (PRC 184, 185, and 186) grants.

PRC 0085 Literacy Intervention Allotment Adjustments

Due to an oversight in calculations of PRC 0085 Literacy Intervention allocations, the Signing Bonus allotment will be reversed for any PSU that did not receive a performance bonus allotment.

The allotment policy manual will be updated to include clarification on the signing bonus eligibility per GS 115C, Article 8, Part 1A which states:

"Each local school administrative unit shall provide a signing bonus in an amount determined by the local board of education that is at least one thousand two hundred dollars (\$1,200) to any teacher who meets all the following criteria:

- 1. Is associated with high growth in reading based on EVAAS data.
- 2. Was awarded a reading performance bonus administered by the Department of Public Instruction.
- 3. Accepts employment to provide instruction during a reading camp."

UPDATE: Child Count (Head Count) Transfer Process

As noted by the Office of Exceptional Children, there will be a change to the methodology of the Head Count Transfer Process. The "transfer" will be an allotment adjustment of the PRC 0032 Children with Disabilities Initial Allotment using the data from the ECATS platform.

The ALOT report, which was utilized in the previous year, will no longer be a part of this analysis. There are no other actions required by the PSU aside from any guidance presented from the Office of Exceptional Children as it relates to the update below.

From the Office of Exceptional Children - All PSUs CHANGE IN PROCESS: Child Count Transfer - NCDPI School Allotment

The Child Count Transfer Process accounts for students with disabilities that move between PSUs during the first 60 days of school and adjusts funding to follow students. During the August 15th, EC Administrators webinar, a change in process was communicated statewide to include the use of ECATS for updating child count numbers for PSUs statewide with no unique required action to be taken locally beyond the normal beginning of the year enrollment procedures.

At this time, the remaining multiple enrollments for students with disabilities must be resolved statewide before the OEC can obtain accurate child count numbers to initiate the transfer of funding to PSUs receiving students with disabilities not originally included in its child count.

Resolving multiple enrollments for both sending and receiving PSUs requires collaboration between local SIS administrators (PowerSchool and/or Infinite Campus) before information can flow successfully in or out of ECATS.

The NC State Board of Education (SBE) approved the changes to the Manuals below during its monthly meeting. The adjustments have been made in each manual and posted to our What's New webpage.

PSU MFR Dashboard - All PSUs

The PSU MFR Dashboards have been updated to include reporting period 4 information. Additionally, a new view has been added to provide PSUs with the ability to see the MFR details by reporting period. The Monthly MFR Details tab shows the encumbrances and year-to-date expenditures by reporting period by purpose and object code. This report can be accessed through the navigation tabs at the top of the screen. We are working with IT and hope to be adding a monthly cash zero out view and a year over year MFR view by December. This is a temporary solution while IT is working to set up individual user access accounts. December Pay Date Reminder - LEAs Only

As noted in our August 22nd newsletter, an internal DPI communication stated that the Office of State Controllers will no longer process the December pay before the holidays and will move the pay date to December 31st.

This communication does not apply to LEAs as the local boards have flexibility in setting their pay dates. However the LEA pay dates must be in compliance with General Statutes. The following are the laws as they apply to LEA pay dates:

Teachers: Although teachers are required to receive a full monthly payment no later than August 31st, and this constitutes prepayment for teachers working on a traditional calendar, the LEA is not permitted to extend the pay intervals more than one month. Therefore, if the LEA pays a teacher before the end of December, the LEA may not extend the next payment to the end of January. Teachers are required to receive their pay in monthly installments (reference <u>G.S.115C-302.1</u>)

Superintendents, supervisors and principals shall only be paid for the days employed as of a set pay date and may not be prepaid for days not employed (reference <u>G.S. 115C-272(b)</u>, <u>115C-285)</u> **Other employees:** Each LEA shall establish a set date on which monthly salary payments to employees other than superintendents, supervisors, and classified principals employed on an annual basis, shall be made. This set pay date may differ from the end of the calendar month of service. Employees may be prepaid on the monthly pay date for days not yet worked (Reference <u>G.S. 115C-316)</u>

Hurricane Helene Capital Recovery Funds

In the aftermath of Hurricane Helene, The Disaster Recovery Act of 2024 – Part II became law on October 25, 2024. Per North Carolina <u>S.L. 2024-53</u>, disaster recovery funding of \$50,000,000 has been appropriated "for repair and renovation of facilities in counties with a federal disaster declaration due to Hurricane Helene for local school administrative units and lab schools. These funds are for unmet needs not covered by insurance or available federal aid."

DPI's Office of School Facilities has been directed to administer Hurricane Helene Capital Recovery Funds for the repair of storm-damaged Public School Facilities in accordance with this Act. Districts located in counties covered by the disaster declaration, and who experienced school facility damage caused by Hurricane Helene, may submit requests for this funding using this form.

Yesterday, the NC General Assembly ratified <u>SL 2024-55 (House Bill 10)</u>. It includes provisions to execute Funding in Arrears as well as \$95 million for the contingency reserve. 
Security Alert: Phishing Email from Unauthorized Google Drive Share

It has come to our attention that several PSU staff members including finance personnel received emails from external Google Drive accounts, which are not associated with NC DPI. These emails often appear to

be legitimate and may contain friendly language, enticing subject lines, or urgent requests. The email typically includes a link prompting you to view or download a shared file.

This specific attempt is involving a Google Drive share from account nnorris@midlandschools.org attempting to impersonate NC DPI that is not affiliated with DPI. The shared document is named "Districts and Schools State Funding FY24-Final 11..24. (NPI).doc". Because the share notification email comes from "drive-shares-dm-noreply@google.com", blocking this address will stop legitimate share notifications from arriving to your users. A screenshot of the email is included below, please communicate this information internally as appropriate to educate users how to identify potential phishing emails.

Official NC DPI shares will always originate from accounts in the "dpi.nc.gov" domain. It is recommended that any users who interacted with the linked document take appropriate actions to ensure secure accounts and devices.

Legislative Update

This week, the NC General Assembly ratified <u>SL 2024-57 (Senate Bill 382)</u>. It includes the following provisions:

Section 1B.1 (Page 2) Clarifies the authorization to pay employees in the Helene impacted PSUs
on days deemed complete to include November. Language is now consistent with the School
Calendar Flexibility months.

- Section 3J.10 (Page 106) Modifies G.S. 115C-218.9 related to appeals for charter schools.
- Section 3J.11 (Page 107) Approves two new Cooperative Innovative High Schools (Dare Early College High School and Rockingham County CTE Innovation High School) effective 2024-25.
- Section 3J.12 (Page 107) Adjustments to the Al School Safety Pilot Program New Hanover County Schools and Davidson County Schools only.
- Section 3J.13 (Page107), the Special Needs Pilot Program removes Alamance, Catawba and Nash County Schools. Replaces with Cabarrus, Union and Vance County Schools.
- Section 3J.14 (Page 108) modifies language related to the SparkNC Pilot Program and opens the
 pilot to all PSUs.
- Section 3J.15 (Page 110) Directs the State Board of Education to waive the portfolio requirement for an administrator license for individuals who meet the stated criteria.
- Section 3J.16 (Page 111) amends the Advanced Teaching Roles Program.
- Section 3J.17 (Page 117) Transfers the Center for Safer Schools out of DPI and into the State Bureau of Investigation, effective immediately.
- Section 2A.1 (Page 13) Appropriates \$120,000 for legal and administrative services at NC School for the Deaf.
- Section 3J.1 to 3J.9 (Page 100) Modifies language related to the independence for the Schools for the Deaf and Blind, and other items related to these schools.

Datafiles and All Closing Grants - All PSUs

Friendly reminder to review data files for ALL ESSER and Federal Grant PRCs that are closing. Please also review the Invalid Code reports provided in the PSU MFR Dashboard related to any of the federal grants that are not recorded to a grant year (in 3X, etc.)

PSUs have had sufficient time to review and ensure your general ledger accurately reflects that information before December 2024 datafiles are due to NCDPI by 11:59 PM Friday evening, January 3, 2025. Datafiles will include all YTD expenditures/encumbrances that need to be recorded by grant year to any federal grants that ended on September 30, 2024. The MFR is a YTD submission and DPI will capture these updates in the December 2024 files.

Failure to correct invalid account codes and missing grant year entries may result in incorrect data file postings and the pulling back of funds during the zero-out process and reversion process.

From the NC Department of Information Technology

Reminder: NCDIT Public School Unit & Local Government Unit Subscription Cost Recovery Billing - All PSUs

This message is to inform you about recent changes to public school unit and local government bills for services provided by the N.C. Department of Information Technology. Beginning with Dec. 15, 2023, invoices, all local government and school system customers now pay a subscription fee, in addition to the service rate to ensure NCDIT recovers its costs as required by law. Subscription cost is the base charge to customers who use NCDIT as a service provider. This charge is to cover the customer's pro-rated share of NCDIT operating expenses.

NCDIT calculated subscription charges for each customer based on their use of IT services (e.g. use of the CICS Mainframe "Region F" MSA Cash Management/Cash Request System).

After determining the average for each customer, NCDIT calculates each customer's percentage of the total. The percentage is then applied to the total subscription budget for the year to determine the amount an individual public school unit or local government is billed.

New SBS Reporting Platform - All PSUs

We are proud to announce the School Business Data Analytics and Reporting Tool (SBS DART) went live today. SBS DART will be the new home of our financial reports moving forward. Internal reports such as the monthly financial reports, cash zero out report, invalid codes report, remaining allotment balances, etc. will now live within SBS DART.

All users who were approved to have PSU level access to their internal financial reports should have received an email today with the directions on how to login and access SBS DART. If you did not get an email and believe you should have received access, please check with your finance officer/director first. If they included you on the approved list and you did not get the email, then you reach out to nathan.craver@dpi.nc.gov and he will follow up with you.

Please keep in mind that 2024-25 is our build-out year and consider SBS DART as under construction. As such, we will be adding reports and features throughout the final part of the school year, and we also welcome your feedback. Hurricane Helene Technology Recovery Funds Process - Helene PSUs Only

In accordance with NC S.L. 2024-54, \$5,000,000 was appropriated for "replacement of school technology, particularly student and teacher devices, in counties with a federal disaster declaration due to Hurricane Helene". NCDPI has created the form linked below for PSUs to request funding for technology damaged because of Hurricane Helene. We request that all PSUs within these counties complete this form to indicate if they are requesting these funds.

The required "Damaged Technology Inventory Template" and "Procedure and Attestation form" are attached to this email or available via the links below. Submissions are requested by the end of **January 31, 2025**, via this form https://go.ncdpi.gov/HTRF-Form. Submissions received after January 31, 2025, will be considered if funds are still available.

Process and required documentation for PSUs requesting funding:

- Compile source documentation to reflect the actual losses and the value of the losses as a result
 of Hurricane Helene. Documentation should include the following.
 - Complete the damaged technology inventory template to identify technology equipment losses and the value of the losses as a result from Hurricane Helene.
 - https://go.ncdpi.gov/HTRF_Damaged-Inv-Template
 - Submit technology equipment repair and/or replacement invoices on form referenced in step three below. Include any other documents that substantiate the claim for State funds to support the repair and replacement of technology equipment.
- 2. Print, review, complete and sign the Attestation Form. The Finance Officer and Technology Director signatures are required to process the claim for State Disaster Funds.

 - One Attestation Form should be completed per PSU request.
- Submit all documents, including the damaged technology inventory, replacement invoice(s), and completed Attestation Form using the Hurricane Helene Technology Recovery Funds Form https://go.ncdpi.gov/HTRF-Form.
 - o Each PSU will receive a confirmation email once all documents are received.
- 4. Complete submissions by the end of **January 31, 2025**. Approved submissions are projected to be included in a February/March allotment.
- 5. Reimbursements will be made through DPI School Business Allotment (PRC 0230).

- Session Law 2024-57 /Senate Bill 382 transferred the Center for Safer Schools to the State Bureau of Investigation. However, you will still receive funding.

Direct Certification (DC) student file upload from Infinite Campus - All PSUs

Note that you are still required to work on the Additional Possible Matches and Extended Eligibility Matches in DC. This process did not change. 2024 Year End Unemployment Invoice

There has been a delay in posting the 2024 year-end unemployment invoices in NCSUITS. DES is projecting that the invoices will be generated this weekend (12/21 and 12/22), and will be available Monday, December 23rd.

DES is statutorily required to have the invoices available no later than December 31 of each year.

Assuming invoices are posted 12/23, we will have until 1/23/2025 until payment is due to DES. You will be required to submit your worksheets and payments due to DPI no later than 1/21/2025.
