#### TITLE IX

Do your men's and women's teams in the same sport get the same level of coaching? The same practice time? The same quality of facilities? The same quality of equipment? The same promotional opportunities?

#### WHO CONTROLS THE MONEY?

Is your booster club spending in compliance?

Schools are responsible for the money spent by booster clubs. If the actions of the booster club put the school out of compliance, the school is responsible for rectifying.

Examples ... Dugout club, Private donor for uniforms

### 3 Prong Test for Compliance

<u>Proportionality</u> - measure number of female participants compared to female population in the school. Roster Spots vs Unique Participants. 3% Variance acceptable.

History - show a demonstrated history of expansion toward proportionality

Accommodating Interests - Survey students and demonstrating that you are meeting the interests of the students
