# **Program Overview**

The Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSA Act) provides \$2.75 billion for the Emergency Assistance for Non-Public Schools (EANS) program, which is part of the Governor's Emergency Education Relief Fund.

NC has received \$84,824,393 for distribution.



## **Program Overview**


Though the Governor must apply for EANS funds, the statute requires that State educational agencies (SEAs) administer the program

In accepting an EANS award, the Governor automatically designates the SEA to administer the EANS program.

# **Program Overview**

Governor's Application approved February 25, 2021

30-day window to open application to approximately 700 eligible schools\* (Application opens March 25, 2021)

6 months to allot funds (August 2021)

Funds not allotted may be then used for public schools.

Period of availability will be through 9/30/2023.



# **Allotment Methodology**



"Base Amount"- flat foundation provided to each eligible school



"Enrollment Share" - based on enrollment for all students regardless of income.



"Low Income Status"

(1) the share of Title I funds directed toward the school district in which the school is physically located

(2) the number of Opportunity Scholarship recipients attending the school

Element	Share %
Base Amount	10%
Enrollment Share	40%
Low Income – Service Area	25%
Low Income – Opportunity Enrollment	25%

At its discretion, NCDPI may require a non-public school application to submit reasonable and appropriate documentation to substantiate one or more of these assurances.

NOTE: If a non-public school applies for a PPP loan on or after December 27, 2020, but does not receive funds under the PPP, the school may apply for services or assistance under the EANS program, as long as the non-public school meets the requirements and deadlines of this application. If a non-public school applied for or received a PPP loan prior to December 27, 2020, it remains eligible for the EANS program. Similarly, if a non-public school applies for but does not receive services or assistance through EANS, nothing in the Education Stabilization Fund would preclude the non-public school from applying for and receiving a PPP loan on or after December 27, 2020.

Section 312(d)(3)(C) requires NCDPI to prioritize services or assistance to non-public schools that enroll lowincome students and are most impacted by COVID-19. Accordingly, the State requests that the school provide the data described below. Such data must not include personally-identifiable information about students or their families.

The NCDPI has discretion to identify the data source(s) it will accept when calculating the number of students enrolled in a non-public school in school year 2019-2020 who are from low-income families. NCDPI also has discretion in determining what it means for a family to have a low income (i.e., NCDPI sets a particular threshold, which could be a percentage of the Federal poverty level or another amount). Each non public school that applies for participation in the EANS program must have a DUNS number to meet federal reporting requirements.


