PART A: Needs Assessment-LEA Data

In the space below provide data the LEA will use to determine its most important educational needs as a result of the disruption in educational services and subsequent shift to remote learning due to COVID-19.

- 1. 14 of 33 report that at least 33% of their students lack broadband access at home, despite all students in the district having access to 1:1 devices.
- 2. 94% of teachers report that lack of broadband access at home is significantly impacting academic progress for at least one of their students; 76% report the same for at least 10% of their students.
- 3. # of teachers self-reporting that they are proficient in the use of remote learning technologies: Elem 44%; Secondary 56%
- 4. The Office of Facilities Management reports that school custodial staff are able to complete their daily assigned schoolwide cleaning manifests 67% of the time, despite being universally trained and having ample access to supplies and materials needed for the job. During the last 10 years, the enrollment has grown by 12% while the custodial staff has been reduced by 25%.
- 5. 2 out of 33 principals report that they expect all students to have access to a sink to wash their hands with warm water immediately before lunch without causing significant delays in the lunch schedule.
- 6. Since early April, high school counsellors have been reporting significant increases in the numbers of requests from students and families for support in dealing with depression and anxiety.

These are detailed and concise statements. They are also measurements that can be re-taken in the future to provide formative evaluation and possible modification of efforts. Lack of custodial staff is a problem worth noting. However, hiring custodians with temporary ESSER funds would raise a sustainability issue, unless their work is designed to be temporary. Maybe this will be addresses somehow in Part D.

1-CCS will use mobile hotspots to give secure internet access to neighborhoods so that students may work from home or will have access at a safe location near their home.)

2 – The district will use funds to recruit new custodians and to develop a sustainable training program to maximize their efficiency.

3 - School administrators and custodial staff will engage in joint training on the implementation of best sanitation practices in the schools, on how to routinely monitor the completion of daily cleaning manifests and how to report concerns to custodial staff.

4 -Additional sinks will be added where needed.

5- The district will contract with social service agencies to provide augmented capacity to help students and their families in dealing with the effects of the crisis.

Timeline for implementation: 1-by June 15, 2020 2-by August 31, 2020 3-by September 30, 2020 4- by September 30, 2020 Make sure that all planned expenditures are allowable. ESSER funds may not be used for capital improvements.

Plan to measure impact:

1: Monitoring number of students who successfully connect through the hotspots and the percentage of students who successfully engage in online platforms during their time away from the school campus

2: Evaluate sufficiency of staffing in October, review quarterly

3: Survey principals and custodial staff to assess their proficiency with the protocols

4: Monitor the amount of time it takes for a classroom of students to wash their hands before lunch;
