
Instructions for Completing the 2024-2025 School Nutrition Online Application Renewal

Step 1: Go to https://schoolnutrition.dpi.nc.gov/snp/NcidLogin.aspx

The SFA has not started in the current year (2025).


Click 'Enroll' to enroll for this year based on your prior year's information.
