Finding Detail: Finding 1: For the month of review (September 2017) at breakfast, Askewville						
Pre-K did not mark rosters at a point of service to justify the number of breakfast meals

claimed daily. Rosters were only marked with an "A" for absent students and there were no marks if a student received a reimbursable breakfast. The marking of rosters at the point of service ensures each student receives one (1) breakfast and provides the basis for the daily count of breakfasts for federal reimbursement. Additionally, the rosters have a title of Daily Breakfast/Lunch thus reviewers cannot determine the meal service. Finding 2: For the month onsite (October 2017) at breakfast, Askewville Pre-K did not mark rosters at a point service to justify the number of breakfast meals claimed daily. Rosters were only marked with an "A" for absent students and there were no marks if a student received a reimbursable breakfast. The marking of rosters at the point of service ensures each student receives one (1) breakfast and provides the basis for the daily count of breakfasts for federal reimbursement. Additionally, the rosters have a title of Daily Breakfast/Lunch thus reviewers cannot determine the meal service. Note: Reviewers were onsite on Thursday, October 19, 2017 and rosters were being properly marked with a checkmark. Additionally, the Zone Operations and Management Consultant was onsite on December 8, 2017 to review rosters and it was determined on this day, breakfast rosters were being properly marked for the claim for federal reimbursement. Finding 3: The eighth-grade class at Bertie Middle School participates in Breakfast in the Classroom. In the months of August 2017, September 2017 and up to the day of review (October 17, 2017), some rosters are not being marked at the point of service to justify the number of breakfast meals claimed. Rosters were only marked for absent students and there are no marks if a student received a reimbursable breakfast. The marking of rosters at the point of service ensures each student receives one (1) breakfast and provides the basis for the daily count of breakfasts for federal reimbursement. Finding 4: On September 26, 2017, one (1) adult meal at breakfast was claimed when the cashier entered a dropped plate as a second meal in the point of sale system. Dropped plates should be documented on the production record and not entered into the point of sale system.

the daily minimum requirements.
