Finding Detail: Haliwa-Saponi's School Nutrition Department incurs the expense for the two vending		
machines within the school. The revenue is being deposited in the Haliwa-Saponi's checking account		
but is recorded as local funds instead of School Nutrition revenue. The SFA has written cash		
management procedures; however, the requirement to track vending sales is not included. Since the		
revenues from vending sales must accrue to the non-profit School Nutrition account, these funds must		
be accounted for in the written cash management procedures.
