Finding Detail: On the day of review, October 10, 2016, the reviewer observed one apple (1 cup fruit equivalent) and 4 oz. juice (1/2 cup fruit equivalent) planned, prepared and available on each table. Juice was poured from a bulk container at breakfast. The portion size for juice was not measured. The meal component portion size could not be verified.

Finding Detail: One cup was provided at breakfast for water and juice. The cup was filled with water prior to meal service. Bulk juice was on each of the two dining tables. Juice was not immediately available for residents. Juice was only provided after residents had consumed water from their cup. All meal components must be provided to residents as part of the reimbursable meal as requested by the Offer v. Serve waiver for Eckerd camps. Table leader counselors and the School Nutrition employees have not received Offer Versus Serve (OVS) waiver training. All meal components must be provided to each student. This facility does not participate in OVS. Servers and other staff directly involved in meal preparation and service must understand what meal components and quantities must be served for claiming federal reimbursement.
