## STATE AGENCY ADMINISTRATIVE REVIEW SUMMARY

Regulations at 7 CFR 210.18(m) requires the SA to post a summary of the most recent final administrative review results for each School Food Authority (SFA) on the SA publicly available website no later than 30 days after the SA provides the results of the administrative review to the SFA. The SA must also make a copy of the final administrative review report available to the public upon request.

		<b>Verification</b> – Validation of the process used by the SFA to confirm selected students' eligibility for free and reduced-price meal benefits			
Finding Detail: The NCDPI has an electronic Direct Verification (DV) matching system. The School Food Authority used the DV process but did not understand the eligibility had to be a perfect match. A student in the household selected for verification did appear in the DV file; however, the eligibility in DV was free and the eligibility determination on the household application was reduced. Since the match was not perfect, the SFA should have sent a selection letter to the household and received a response. Since this was the last day of verification, the SFA was able to receive the income information from the household. No further corrective action is required.					
$\boxtimes$		<b>Meal Counting and Claiming</b> – Validation of the SFA's meal counting and claiming system that accurately counts, records, consolidates, and reports the number of reimbursable meals claimed by category			
Finding Detail: Accurate meal counting and claiming and offer versus serve were not implemented properly during breakfast for the 7th and 8th graders. The reviewer observed breakfast service and the meal counting process for 7th and 8th graders in the cafeteria on November 15, 2016. Several students went through the line and did not take the required ½ cup fruit component. The reviewer reminded the cashier that the students did not select a reimbursable meal, so the cashier called the students back to obtain a fruit component; however, two students still proceeded to pass the point of sale without a fruit component. Two breakfasts meals are disallowed on November 15, 2016 for a potential reclaim of \$2.33.

Finding Detail: Hickory City School's Central Office has three different central food storage locations.					
		Warehouse location at an old school that is within very close proximity to the Hickory City			
		tion Office and used mainly for USDA commodity canned foods and paper supplies. There ad freezer at Hickory High School and a designated space for frozen food that is located			

within the Catawba County Central freezer. The NC Hazard Analysis Critical Control Points (HACCP) Plan has not been fully implemented in two of the three central office storage locations, Hickory High School and Catawba County Central freezer. An area requiring attention includes receipt date marking for inventory to include the month and year to meet requirements for first-in, first-out (FIFO) inventory management.  The Central Warehouse HACCP Plan is limited to the dry storage area for canned USDA commodity foods and paper supplies. The Central Warehouse HACCP Plan should include the frozen food stored in the designated freezer at Hickory High School and also at the Catawba County Central freezer.  The NC Hazard Analysis Critical Control Points (HACCP) Plan has not been fully implemented. An area requiring attention includes receipt date marking for inventory to include the month, day, and year					
to meet requirements for First In First Out (FIFO) inventory management. The majority of items in inventory only had the month and day received.
