<p>Finding Detail 1: Small Purchases - The School Food Authority has not executed the Procurement Plan adequately in “free and open” competition. There was no documentation for obtaining quotes from vendors on items purchased under the School Food Authority’s small purchase threshold. Following the Procurement Plan procedures are required to ensure consistency and free and open competition among all vendors.</p> <p>Finding Detail 2: Formal Purchases - The School Food Authority has not executed the Procurement Plan adequately in “free and open” competition. There was no documentation for a bid solicitation for Bull's Eye/SmartMouth Pizza. Following the Procurement Plan procedures are required to ensure consistency and free and open competition among all vendors.</p> <p>Finding Detail 3: Perquimans County Schools’ small purchase threshold of \$10,000 is inconsistently reported in the Procurement Plan.</p>

<p>Finding Detail: The on-site annual breakfast review at Hertford Grammar was conducted and completed on February 12, 2025, which is after the required deadline of February 1st. According to 7 CFR 210.8(a)(1) and 7 CFR 220.11(d)(1), every school year, prior to February 1, each School Food Authority (SFA) with more than one school (as defined by 7 CFR Part 210.2 to include Residential Child Care Institutions (RCCIs)) must perform no less than one on-site review of the meal counting and claiming system and the readily observable general areas of review identified under 7 CFR 210.18(h) in each school operating the National School Lunch Program (NSLP) and 50% of schools operating the School Breakfast Program (SBP) under its jurisdiction. Technical assistance was provided during the Administrative Review.</p>
