Remember to Submit 2020-21 Verification Reapplied and Reapproved Survey

Please submit the <u>2020-21 Verification Reapplied and Reapproved Survey</u> by March 3. This survey has been developed for all School Food Authorities (SFAs) that completed a verification report with the exception of Special Milk Program SFAs, District-wide Community Eligibility Provision (CEP) SFAs and Residential Child Care Institutions (RCCIs) without day students. The purpose of the survey is to capture the data on Reapplied and Reapproved Applications and Students on or before February 15, 2021.

Please provide the number of student(s) and the number of application(s) for each category listed in the survey for households that were originally selected for verification (October 1 - November 15) for which benefits were terminated and the household reapplied for benefits between November 16, 2020 and February 15, 2021. Please remember the original termination of benefits may have been because:

- the household did not respond to verification,
- the household responded to verification, but benefits were changed from "Free" to "Denied", or
- the household responded to verification, but benefits were changed from "Reduced" to "Denied".

It is important to submit data for "Students" and "Applications" in each category in the survey. If there is no data for a particular category, please enter a "0". For any questions, please reach out to your <u>Zone teams</u>.

Congratulate the 2021 N.C. Jr. Chef Finalist Teams

Four teams of high school Career and Technical Education students enrolled in Culinary Arts and Hospitality, Food and Nutrition, or Food Science and Technology courses will vie for the state title in the virtual 2021 North Carolina Jr. Chef Competition. Based on applications and recipes submitted, Apex High (Wake County Public Schools), Clyde A.



Erwin High (Buncombe County Schools), East Chapel Hill High (Chapel Hill-Carrboro City Schools) and Swain County High were selected as finalist teams. This is the fourth year of the competition, but it is the first time teams will compete in a virtual format. Read the finalists announcement <u>press release</u> from NCDPI.

For the next phase of the competition, teams will submit a video of their Jr. Chefs preparing and plating their school lunch entrée recipe. Along with the video, teams will re-submit their applications, recipes and recipe photos, incorporating feedback from the recipe review panel by March 19. In addition, they will turn in a time management plan for how they can prepare their dish within the 90-minute time limit.

Teams will present their dishes during virtual, live interviews in early April with judges. All finalist teams will be recognized and the results of the competition will be announced during a virtual ceremony on April 16 as part of the N.C. FCCLA State Leadership Conference. All students will receive certificates and medals based on their team scores. Members of the top three teams will be offered scholarships to attend Sullivan University in Kentucky. For more N.C.
