Check Out the Food Buying Guide for Child Nutrition Programs

The <u>Food Buying Guide for Child Nutrition Programs</u> (FBG) is the go-to resource for determining the amount of food to purchase and the contribution that foods make toward meal pattern requirements. New food yield data continues to be added, with the latest additions being brown lentils, individually quick-frozen (IQF) red beans, IQF black beans, IQF pinto beans, roasted soybeans, roasted chickpeas, fresh oranges, grape tomatoes, ready-to-use diced and sliced onions, and frozen cubed sweet potatoes. The FBG has also been updated to increase the diversity of foods listed, including



traditional Indigenous foods, such as bison, tepary beans, and salmonberries. When a user searches for one of these food items, yield data will display for that similar food. Users may use that data to determine how the food meets meal pattern requirements. Check it out and explore all the features the FBG has to offer!

School Nutrition Spotlight

Recognizing USDA Farm to School Grantees

The U.S. Department of Agriculture (USDA), Food and Nutrition Service (FNS) recently announced that it is awarding \$10.7 million in 2023 Patrick Leahy Farm to School Grants to fund 103 projects across the country. These investments will help 1.2 million children from nearly 3,000 schools in 40 States and the territory of Guam eat tasty, nutritious local foods, while supporting farmers and producers in their communities. This year USDA is celebrating the 10th anniversary of the Farm to School Grant Program! Since the program's inception in 2013, the department has awarded nearly \$85 million in Farm to School Grants, funding more than 1,100 projects across all 50 states, the District of Columbia, U.S. Virgin Islands, Guam, and Puerto Rico. These projects have reached over 28 million students in nearly 65,000 schools.

In North Carolina, the Appalachian Sustainable Agriculture Project (ASAP) and partners across Haywood County received a 2023 Farm to School Grant to adapt existing Farm to School (F2S) curriculum to serve high school students in Career and Technical Education (CTE) programs. Partnerships for this project include the School Nutrition Director and CTE Director of Haywood County Schools, Haywood Cooperative Extension,

Haywood Cooperative Extension, Haywood Community College, and a local farmer supplying Haywood County Schools. As a result of this collaboration, student coursework will be enriched through first-hand local food and farm experiences, increasing consumption of local food, igniting student's interest in agricultural careers, and building connections across their cafeteria, classroom, and community.

Farm to School Grant projects create opportunities for children to learn about nutrition and agriculture through hands-on experiences, such as planting, watering, and harvesting fruits, vegetables and herbs. Many funded grant projects also provide a pathway for more children to achieve nutrition security, which is the consistent and equitable access to healthy, safe, and affordable foods essential to optimal health and well-being. 2024 CHS Foundation Classroom Grant Application – Due 9/15

The CHS Foundation provides \$500 grants each year to pre-kindergarten to 12th grade teachers who have classroom projects that use agricultural concepts to teach reading, writing, math, science, social studies, and more. Eligible projects include classroom and schoolyard gardens, embryology projects, aquaculture projects, and agricultural literacy reading programs to name a few. Teachers have until June 1 the following year to

complete the project and submit a final report. Only-state certified classroom teachers employed by a school district or private school teachers are eligible to apply. Share this opportunity with your teachers. Learn more.

Learn about the Farm to School Technical Assistance Cooperative Agreement – Deadline 10/10

The Patrick Leahy Farm to School Program is proud to announce the release of the FY 2024 Farm to School Technical Assistance Cooperative Agreement Request for Applications (RFA). This RFA supports the Farm to School Program's ability to provide technical assistance to farm to school stakeholders; expand farm to school activity nationwide; and contribute to the accomplishment of three USDA priorities: Food System Transformation, Improving Child Health Through Nutritious School Meals, and Indigenous Food Sovereignty. USDA will fund up to four total applicants using three tracks: Supporting Community Engagement, Supporting Tribal Engagement, and Supporting Producer Engagement. Eligible applicants include 501(c)3 non-profit organizations and Indian Tribal Organizations (ITOs). USDA will award approximately \$3 million in Farm to School Cooperative Agreement funds. Applications are due October 10, 2023. Learn more.

Provide Input on Draft N.C. Health and Physical Education Standards – Due 9/18

The N.C. State Board of Education, Standard Course of Study Manual specifies that NCDPI will formally collect feedback from educators, administrators, parents, students, institutions of higher education, business/industry representatives, national organizations, and other education agencies on each draft of the revised N.C. K-12 Health and Physical Education Standards. A survey has been released to gather feedback on the first draft of the proposed 2023 N.C. K-12 Health and Physical Education Standards. The purpose of this survey is to obtain input from all stakeholders regarding the proposed standards and to inform any additional revisions, which may include changes, clarifications, additions, deletions, or replacements to the draft standards. The surveys close on September 18, 2023. Your feedback is extremely valuable to the Healthful Living standards revision process.

The Turnip the Beet Award, from the U.S. Department of Agriculture (USDA) Food and Nutrition Service (FNS), recognizes outstanding Summer Meal Program sponsors who work hard to offer high quality meals that are appetizing, appealing, and nutritious. All Summer Meal Programs sponsors in good standing, including Summer Food Service Program (SFSP) sponsors and National School Lunch Program Seamless Summer Option (SSO) sponsors, may be eligible for a Turnip the Beet Award. Sponsors may self-nominate or be nominated by another party. Participate in the Food Hub Feasibility Study Webinar Series

The Saratoga Cornell Cooperative Extension (CCE) USDA Food Hub Feasibility Study Webinar Series will be of interest to all who are in any way connected to our food supply – farmers, farmers markets, supermarkets, food banks, etc. The Food Hub Feasibility Study webinar series explores the findings of a study conducted by Saratoga CCE, which was funded by the USDA's 2021 Local Food Promotion Program grant. Through research, analysis,

and on-the-ground work, this study details available and potential markets for local foods. They offer recommendations to best service the local food system that considers farm to institution, distribution, infrastructure, food access, the emergency food system, and climate change.
