Apply for the Budding Botanist Grant - Due 10/30

If your school will use a new or existing garden program to teach about environmental sustainability and the importance of biodiversity you should apply for a Budding Botanist Grant, worth \$1,200! Fifteen schools across the country will be awarded Budding Botanist grant packages. Whether learning remotely, in person, or in a hybrid model, any public school, charter school, or private school serving students in grades K to 12 in the United States that can demonstrate that at least 40% of their student population would qualify for free or reduced price meals is eligible to apply. Applications that propose projects focused on the creation of virtual garden-based learning opportunities or take-home gardening kits to better serve students engaged in remote learning will be accepted.
