Only a two (2) ounce spoodle of croutons was offered to students that chose the chef salad. Based on the Food Buying Guide for Child Nutrition Programs, the adequate portion size is one (1) cup of croutons equaling two (2) ounce grain equivalent serving per day. Based on the 9th-12th grade lunch meal pattern, students must be offered at least two (2) ounces of grain equivalent serving per day and ten (10) ounces grain equivalent per week.
