<p>Finding Detail: Production records for multiple days in the month of review (December 2023) documented inaccurate numbers in the leftover column for the multiple entrée choices offered. This could lead to the question whether all components were available to all students. Numbers recorded on the production record should accurately depict what occurred on the day of production. The quantity of meals served on the day of review supports meal pattern compliance and the number of reimbursable meals claimed.</p> <p>Finding Detail: Lunch production records for multiple days in the month of review (December 2023) documented inaccurate numbers in the leftover column. This could lead to question where leftover components were either kept or discarded at the end of the day. In addition, the quantity available column (14) showed inaccurate servings of reimbursable meals served. Numbers recorded on the production record should accurately depict what occurred on the day of production. The quantity of all entrees served on the day of review supports the number of reimbursable meals claimed.</p>
