Finding: Adults outside of the School Nutrition Program are being permitted to charge meals as part of a “Foster Grandparent Program”. The non-profit School Nutrition account cannot be used to supplement adult meals outside of the School Nutrition Program, therefore adult meals are not allowed to be charged. During the review, a report was generated showing outstanding meal charge balances by adults of \$112.40.

Finding Detail: There was no documentation of non-domestic foods from the School Food Authorities (SFA's) main distributor (Sysco) approved for meal service by the SFA. Federal regulations require all non-domestic agricultural products, used in the School Nutrition Program, to be pre-approved by the School Nutrition Administrator and documented at each school site.
