- 3. Eligible service providers participating in waiver and affirmation that they are in good standing: Sponsors of the National School Lunch and School Breakfast Program who are not found to have significant deficiencies as a result of the NSLP Administrative Review.
- 4. Description of the challenge the State Agency is seeking to solve, the goal of the waiver to improve services under the Program, and the expected outcomes if the waiver is granted. [Section 12(1)(A)(iii) and 12(1)(2)(A)(iv) of the NSLA:] The North Carolina Department of Public Instruction (NCDPI), School Nutrition Division, seeks to support sponsors of the National School Lunch Program and School Breakfast Program as they return to standard program operations. The majority, if not all, of sponsors in the state have operated SFSP or SSO over the past two years. As sponsors transition back to NSLP, NCDPI recognizes the importance of the Community Eligibility Provision as it provides a mechanism to continue to provide meals at no cost to students. For eligible schools, sufficient time to collect the necessary data to elect CEP for SY 22-23 is necessary as they continue to respond to and recover from the Pandemic.
