Policy, Monitoring and Audit

Tips: Indicator 11

- LEAs should run their Timely Placement Report routinely.
- Ensure the SPED screen is completely filled out with dates, etc. – even if consent or eligibility was “no”.
- Make sure forms have been closed/verified.
- “Exclusions” must be recorded in CECAS before the 90th day.



Policy, Monitoring and Audit

Tips: Delays from Hurricane Florence

- Indicator 11
 - LEAs may record the reason for a delay as “weather”; however, this is not an allowable exception to the timeline.
 - The SEA will record this event in our reporting of state-wide data.
 - Consultants will problem-solve individually with impacted LEAs to resolve their local data.
- IEPs
 - For IEPs that expired during the hurricane and delayed school returns, please provide comparable services to the most recent IEP and schedule an IEP Team meeting as soon as possible.
 - When the IEP Team meeting is held, note the delay of the annual review as a result of Hurricane Florence/school closings in “Other Relevant Factors” on the prior written notice.

Behavior Support (PRC 29)

- Funding for selected LEAs for Behavior Support was allocated through PRC 29 and PRC 118.
- LEAs received 98% of funds through PRC 29 and the remaining 2% in PRC 118.
- Funding summary reports will be due Jan 31 and July 15
- Remember PRC 29 funds must be used by the end of the year !! (June 30th)
- Please review your PRC 29 budget each month so you're on target to spend all funds by the end of the year.

PBIS FUNDING

- IABS Division will allocate funds for PBIS through PRC 29.
- Funds should be used for training purposes only and cannot be used for personnel.
- LEAs may want to consider creating an identifier to distinguish the funds from other sources.

 - MTSS module training for Tiered Behavior Support.


