  - The Common Education Data Analysis and Reporting System, known as CEDARS, is North Carolina's PreK-13 State Longitudinal Data System. The system is composed of various DPI source data collection systems, a student and staff identification system, a centralized data repository, and associated reporting and analysis (or "business intelligence") tools.
  - o Role-based Security: Within an organization, roles are created for various job functions. The permissions to perform certain operations are assigned to specific roles. For example, the role of "Teacher" allows the user to view the data for students in one classroom. The role of "Principal" allows the user to view the data all of the students in the school. Staff are assigned particular roles, and through those role assignments acquire the permissions to view particular data. Since users are not assigned permissions directly, but only acquire them through their role (or roles), management of individual user rights becomes a matter of assigning appropriate roles to the user's account.
