Special Called Item: Agape Achievement Academy Ready to Open Status: Ms. Ashley Baquero, OCS Director

 Ms. Baquero provided background on Agape Achievement Academy, a charter school slated for Cumberland County that was tabled at the June 9, 2025 meeting due to budget concerns. The school was asked to resubmit a budget at their break-even enrollment of 126 students for grades K-3 in year one.

Presentation by Agape Achievement Academy

Representatives Present: William O'Kelly and Dr. Doris Taylor

Key Points Presented:

- Current enrollment: 126 students (at break-even)
- Facility: 11,000 square feet
- Budget highlights for year 1: Total expenditures \$1,177,351.50, total revenue \$1,177,914.20, surplus \$526.52
- Received donation of 49 computers
- Located within 5 miles of military base

Board Discussion and Concerns:

Technology and Operations Budget Concerns (Mr. Friend):

- Questioned adequacy of \$11,000 for classroom devices and software for 126 students
- Raised concerns about \$5,000 legal services budget
- Noted \$5,000 staff development budget for 13 staff members (\$400 per person)
- Questioned combined custodian/bus driver position at \$10,000

Instructional Materials Concerns (Dr. Shope):

- Expressed concern about \$10,000 budget for instructional supplies and materials
- Emphasized tight margins with only \$500 surplus

Enrollment Projections (Dr. Haire):

- Questioned inconsistent enrollment projections showing 21 students in kindergarten for year two versus 42 in year one
- Identified error in enrollment pattern that should be corrected

Funding Discrepancies (Dr. Haire):

- Questioned "Other Funds" category showing \$45,000 in year one
- Identified significant discrepancy in federal EC funding projections
- Noted projected 13 EC students should generate approximately \$20,000-\$28,800 in federal funds, not \$45,000+ shown in budget

Staffing Status (Ms. Kakadelis):

• Confirmed school has hired 4 teachers, data manager, operations director, principal, custodian, and is interviewing EC teacher

Additional Revenue Sources (Mr. Friend):

CSRB Special Called APPROVED 0625

- School indicated potential for 21st Century Grant and other grant opportunities
- Confirmed relationship with First Horizon Bank for potential loan if needed

Discussion: Board members expressed concerns about:

- Inadequate understanding of budget components
- Unsubstantiated funding sources
- Very thin operating margins with no reserves
- Risk of financial difficulties after opening
