- **Related Services:** DeafBlind Intervener will be an option based on the information shared in the Weekly Update on 2/22/23. DeafBlind Interveners were added to the Class Specifications for Noncertified Public School Employees in 2022 as individuals who may support learners with Deaf-Blindness. UPDATE: Service Documentation Module

Effective March 13, 2023, only students with finalized IEPs will pull into the **traditional** service logging wizards. Students must have a finalized IEP with that particular related service on the IEP. For example, a student must have a finalized IEP with Speech/Language to pull into the Speech/Language Logging Wizard.
