Due to school closures in spring 2020, many teacher candidates were not able to complete edTPA in their clinical placement/internship and were offered a waiver to complete edTPA in the 2020–21 academic year. Other candidates are affiliated with an EPP that may not use edTPA. To support these groups of teacher candidates, SCALE and Pearson are offering this webinar series. In each of these 60-minute webinars within the webinar series, teacher candidates will receive guidance from how to get started to how to with completing edTPA.

Candidates **must** be registered for edTPA to access the assessment materials (e.g., edTPA Handbook, templates, URLP, Academic Language handout) used to complete edTPA and will be reviewed during these webinars. Registration can be completed at [edTPA.com](https://www.edtpa.com).
